You can't kill the (Twyford) spirit
You saw it here first in AU9, and the latest anti-roads camp is up and already very active. It has become the natural rural successor to Twyford Down. Solsbury Hill hopes to be the rallying camp for the summer. Bath EF!ers and SOS (Save Our Solsbury) were desperate for people in the middle of March, and sent the movement this message:

"Opposed by many local people, the Scheme will destroy vast areas of common land, farmland, trees and hedgerows, including a large slice of Solsbury Hill, a popular local beauty spot where an iron-age hill fort can be found. Also under threat is a badger sett with up to 10 adults and between 1-3 litters of cubs, and a newt pond. 20 homes will be bulldozed. So much of what I care about is under attack here.... and what for? Road-building in the 90s is clearly such a pointless, outdated and tragic waste of everybody's time, money and natural environment" (Sarah Bath EF!). Cont p2

MORE OF AN PARTY THAN A MARCH!

The Injustice-to-people-who-just-want-to-get-on-with-their-lives-Bill has drawn together anti-roads people, travellers, ravers, sabs, and the generally-pissed-off-with-the-latest-Tory-outrage. Full credit to the Advance Party for organising a non-violent afternoon of fun and thoughtfulness in the sun, no credit to the heavy handed Metropolitan Police for doing their utmost to turn the Criminal Justice Bill (CJB) rally into a riot. Solsbury Hill Update and Latest News

14th March, the day the contractors (AMEY) were due to start, they did not start for two days due to totally unexpected protests. The work was regularly blockaded by protesters as ARC, who are supplying roadstone, tried to get their plant onto the site. By the 25th March, 2 houses were successfully squatted, and the protest camp was set up on Solsbury Hill. Some houses were reclaimed so easily that ACE Security have now been replaced with Reliance (also at M11)

26th April - After a court case in which some of the land was spared by the judge, bailiffs moved in and cleared the land of protesters. There were 7 people in trees, two of whom managed to stay until the bailiffs moved in to the rest of the water meadows on 2nd May.

28th April, 4 houses and surrounding land were issued with eviction notices. While In court, the bailiffs attempted an illegal eviction of the 'Nursery', but this was stopped. In a solidarity action, 10 people walked into the offices of AMEC near Oxford and delayed work for 4hrs.

About 2-300 people turned up to the Beltain fire festival. Saturday saw an action against AMEY, about 60 people stopped trucks entering and leaving the site. Security made 3 citizens wrests under section 10 of the Criminal Law Act (obstructing a sheriff in the course of his duties), when there was no sheriff actually there. The police arrived and charged the 3 people with breach of the peace, these people were held in the police station for 2 hours and then released without charge.

Saturday night a digger made of wicker was burned on the hill, with fire juggling, etc, and on Sunday houses were barricaded as we danced around the maypole as.

2nd May a dragon procession made its way to the water meadows from the hill, this involved an invasion of the site and dancing around the remaining trees which were still occupied by two activists. An 'aerial village' in beech trees near the water meadows was constructed.

3rd May, all the houses were barricaded, about 100 people stormed the construction site and occupied a large crane which was to be used to get people down from the trees, also two diggers were surrounded, work was stopped totally on the site all morning.

4th May was the major eviction day when most of the site was reclaimed under pretty vicious circumstances, in poor false the Police called it Operation Greenbelt. Three houses were knocked down, leaving only one which is heavily guarded.

5th May, AMEY try to bulldoze the garden of Tania's family (infamous protester), neighbours and friends move in with tents and benders while others went to the Hackney Homeless festival. The locals are now really getting into the campaign and seem to be able to avoid arrest unlike EF!ers and Dongas.

M-WAY DEMO MOB CAMP ON MINISTER'S ROOF

MOTORWAY protesters made top Tory John MacGregor hit the roof yesterday — by camping on top of his house.

Nine demonstrators scaled the Transport Secretary's home in a dawn raid which sparked a £10,000 police and fire operation. They climbed a 50ft ladder and roped themselves to a chimney before

unfurling flags and banners, including a huge picture of a road.

Mr. MacGregor was awoken at 6.30am by footsteps clumping across the roof of the £250,000 house in Muswell Hill, North London.

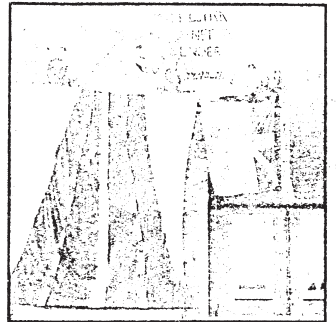
An hour later he left in his ministerial car to shouts of "Homes not Roads." He would not speak to the

protesters, who say a new M11 link road in East London will make them homeless.

The stunt, named Operation Seven after the house number, ended after five hours.

Supt Huw Thornton said: "All they succeeded in doing was terrifying and shocking Mrs MacGregor."

The nine were charged with disorderly behaviour. One campaigner said: "We want Mr MacGregor to know something about the human cost of his monstrous road-building programme."

Operation Roadblock

Operation Roadblock has now been and gone; a great success which will be an inspiration to other road schemes throughout the country. It started with 'Lollipop Ladies' helping pedestrians over the as yet not existing road - estimated cost of this crossing: £50,000. In the next three weeks 1,200 people regularly stopped the earth trashers. Pensioners were hauled off of machinery and schoolchildren demonstrated their energy with er... demonstrations. After a month of continuous action, a rally was held at the Bush Wood site, heralding the end of Roadblock 1. Recently security guards have taken the Fillibrook Road site and are taking the houses apart with pick-axes. Maybe they have no working plant left??? The campaign is now concentrating on three fronts: Leytonstonia, Claremont Road and one day per week of direct action. The campaign has issued a call for help for anyone with time to spare to go and help with these worthy projects. Every Monday is direct action day, so meet at the office at 9.30am for a briefing (see also page 2)

GOLFERS SENT TO COVENTRY....



It has come to our attention that much loved area of Coventry, which is a Site of Importance for Nature Conservation (the golf course site, not Coventry), is under threat. The villains of the piece are Hearsall Golf Club, and Coventry Earth Spirit are not best pleased. The issue is currently at a relatively early stage but there has already been considerable outcry from concerned individuals and groups. The latest growth area of radical activity is North of the border. With the Skye Bridge Campaign, Super-quarries and an ever-growing number of EF! groups, radical activism in this area is fighting back.

The Superquarries came to the forefront of activity when Edinburgh EF! stormed and disrupted a conference entitled 'Coastal Quarrying in Scotland - A Way Forward.' Activists unfurled banners, beat drums and sang happy songs, while the delegates pulled long faces and looked rather weary. During their stay several concerned individuals were assaulted by members of the hotel staff. The action was in protest at the wholly destructive qualities of the quarries, which involves the digging up of whole mountains, (in Harris, a hole deep enough to bury the Empire State Building!)

Glasgow EF! is a new group, set up approximately 2 months ago, and already it is reaching the national press. Their M77 protest, targeted at the destruction of Pollok Park, one of the few green spaces in the city. With actions and enthusiasm such as this, is it any wonder that some English activists are moving Northwards?

Strathclyde road planning office occupied....

On 22nd April around 40 EF!ers occupied the office of the road planning department of the Strathclyde regional council in protest at controversial plans to construct the £70.2 million 11km-long M77 motorway extension through Glasgow's Pollok Estate - the largest green urban area in Europe.

At 8:00 am activists entered the building to disrupt the move of the regional council's road-building department into the new premises. The activists occupied the 5th floor and staged a constant picket outside for 3 hours after which they left of their own choice. Work in the entire building was severely disrupted for the morning. The group occupied and padlocked the doors of the regional roads department, and hung banners from the rear of the building and stopped employees entering. The police had to call the Fire Brigade to cut the padlocks and several had chained themselves to desks before leaving after three hours of agitation. There were no arrests, and then it was time for "an arse kicking party".

Pollok Park, a 1008 acre area of woodland and fields, was given to the people of Glasgow and given legal protection in 1939. It was a gift by Sir John Stirling Maxwell and marked the beginning of the National Trust for Scotland, who have been entrusted to protect it from development, but have since sold the area needed for the road to Strathclyde regional council. Part of the route has already been constructed but was postponed due to lack of funds. More money has since been collected, including funding from the European Union, and construction work may begin December 1994.

.....and Scottish Nuclear

The Scottish Nuclear headquarters in East Kilbride near Glasgow were also invaded. A full report of the action will be forthcoming shortly.



Walk For The Earth

(WFTE) are back again after there Northern Road scheme walk last September with a new one. They are leaving Wanstonia on June 11th and travelling to Manchester Peace Festival by the 25th June. They are passing various road schemes and nuclear sites on the way, including the motorway widening unit and Birmingham the day before the public inquiry for the Northern Relief Road opens. Tower Seige!

For a number of months now, Oxford EF! have been running "Oxford Is Choking", a direct action-based campaign to get cars and buses out of the city centre. Past actions have seen a growing number of people cycling round and round the Iain, the major roundabout in Oxford, causing traffic chaos.

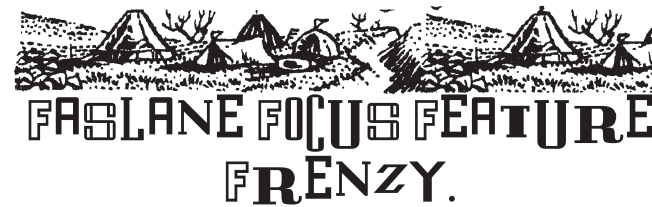
On 3rd May four 'tourists' paid £1.20 to enter Carfax Tower, a city centre landmark in Oxford. Using pieces of wood, they wedged the doors closed then attached banners to the top of the tower and flagpole. The protesters refused to come down again until the air below is clean enough to breathe safely. Below, protesters dressed in white suits and gas masks held placards banged drums and handed out leaflets to passers-by. About 1000 leaflets were handed out to general approval. The action was designed to coincide with the local elections.

The protesters spent the night sleeping in hammocks and came down at 9.30am the next day. The Green Party took Central Ward and narrowly missed St Clements ward by 100 votes.

NORTH WALES EF! HUNT THEIR QUARRY.

North Wales EF!'s first planned day of action (Welcome aboard!) against Bethesda Quarry (McAlpines) was on April 27th. Mass ecological disaster is being inflicted upon the land by that paragon of corporate virtue Alfred McAlpine. Together with the district council they plan to, in the words of one EF!'er, '... build a concrete abattoir on a green field site.'

Also, this relatively young but vibrant group also carried out an anti-nuclear action at the Wylfa plant on May 3rd. More activity is currently being planned, so if possible, go and join them, there'll be a welcome in the hillside for you.



Faslane Peace Camp sits outside the Clyde submarine base, home of Britain's nuclear weapons, on the Gareloch - 30 miles NW of Glasgow. Just over the hill is Coulport, 3000 acres of once beautiful land, now concreted, razor-wired and hiding the planet's greatest threat in its underground bunkers.

Once a month huge convoys of articulated lorries carry the new Trident warheads from their factory at Burghfield, near Reading to Coulport. They travel on the busiest roads and through the middle of many towns and cities e.g Glasgow, Edinburgh... If one of these lorries crashed we're looking at either a full scale nuclear explosion or, more likely, a massive release of deadly radioactive Plutonium into the air, water and soil!

13 of these convoys have travelled to Coulport in the last year. Faslane Peace Camp has stopped, painted, climbed on and delayed 11 of these (the other two broke down), despite a massive military and police presence.

In the last year there have been over 160 arrests for direct action here including stopping convoys, ramming Vanguard, the new Trident submarine, blockades, break-ins and much more. Apart from 38 arrests at the successful September blockade, most of these actions have been carried out by regular campers only and the charges, fines and prison sentences are building up.

Recently the camp celebrated its 12th anniversary, and although the community is well established, it always welcomes visitors to its perimeter (unlike the M.O.D). Bring bolt-cutters and let's see these fences tumble as we reclaim the land that is rightfully ours.

SPIRAL TRIBE ACTION

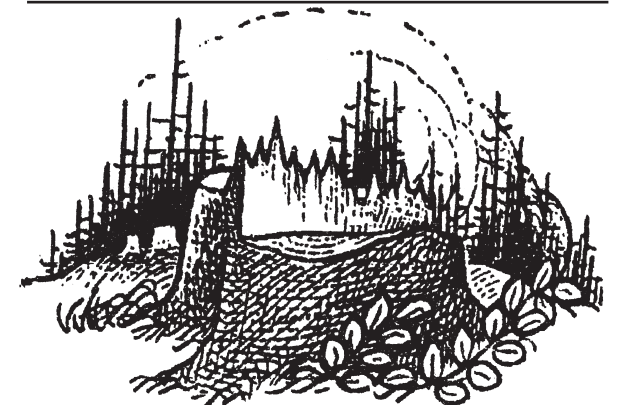
Dense forestry around the Coulport armaments depot provided extra cover for those involved in the Spiral Action on Sunday 20th March. Activists engaged in 'hit and run' tactics, continuously cutting the fence only to disappear, regroup and emerge further along the tree line at the sight of police. 3 men were later arrested after being identified using boltcutters earlier in the day. 4 others were also detained but released without charge.

That same evening 4 women were picked up within the perimeter of the base. They had managed to cut their way inside, evading infra-red surveillance cameras and using carpet to scale the razor wire. All 4 were charged with Byelaws.

On the second action, 50 people swarmed over the Nuclear Warhead Convoy as it tried to run the peace camp gauntlet when leaving Coulport. Seventeen more were arrested having been dragged from the top of the warhead carriers. Paint was also smeared on the windscreens. Two men climbed a tree enabling them to gain access to the roof of one of the trailers. Charges were Breach of the Peace and Vandalism. Three protestors were Quik-Kuffed.



Norwich - The Greenhouse, which houses Norwich EF!, Hunt Sabs and other groups plus the shop, has now set up a charitable trust and bought the building next door to treble the size of the centre. The building has been gutted and architect's plans have been drawn up. Work on the restoration of this listed building has started but the Greenhouse are appealing for people to come and help. OPERATION TREEWATCH

For a week Oxford FoE, EF! and concerned residents used direct action tactics to stop trees being cut down indiscriminately. Activists twice brought work to a standstill by climbing into the trees which were due to be cut down and locking onto the machinery of the tree 'surgeons'. Some surgeons were escorted away by police when protesters climbed into trees on the centra! reservation. EF!ers have managed to stop work despite an unreasonably large police presence - 6 police vans and 20-30 police for 16 protesters on one day. However, no arrests have been made, the protesters will continue until the Department of Transport agrees to suspend work completely. The Department is quoted as saying the trees were being cut down as they were either a hazard or dying (well, they're dead now). A further action at 4.30am on Saturday 26th March did not manage to stop the remaining trees from being cut down.

The DoT makes great show of the number of trees it plants every year (they publish figures) but cannot tell us how many they destroy. Ironically, of course the trees along Oxford Ring Road were planted by the DoT when they built the road!

New DoT rules are leading to large-scale destruction of trees 16 metres along both sides of all major roads. They also have a blanket policy of removing various species including indigenous ones such as Elm, Cherry and Willow, even if perfectly healthy.

Oxford EF! have compiled a briefing document, which is available from them.

The Return of CRISP-O

Under the auspices of CRISP (Citizen's Recovery of indigenous People's Stolen Property) Officers all around the country 'ethically-shoplifted' mahogany and took it to police stations asking them to investigate allegations that the wood is stolen from indigenous people's land. No-one was prosecuted for shoplifting, although at the time of writing Stroud EF! are going through the courts. CRISP-O's happened all around the country at the end of 1993, but have ground to a halt as people see little movement from the police. A mahogany meeting in Norwich on 7/8 May decided to relaunch CRISP-O - with a difference.

The problem has been that local police forces have just been handing the mahogany back to shops which has pissed everyone off. This time the idea is to shoplift the goods, tell the police, and then take the goods to London and give them to the Attorney-General - the highest law-lord in the country, and ask him to investigate our claims. We want to see a huge pile of wood dumped either in his office, or, if we can do it, given to an MP in the House of Commons (MPs are above the law within the House of Commons, so should not be worried about receiving stolen goods. The action is still being finalised but the date is the 14th/15th June. Experience suggests that this is a great way to get new people involved in what is a very simple action. Remember: the planet is dying, and the people who are killing it have names and addresses and roofs to squat!

Rio Tinto Stink!

Dozens of sacks of rotting fruit and vegetables were dumped on the steps of mining giant RTZ's head offices in March. RTZ, who recently celebrated coming first in Survival International's 'worst of the world's worst companies with respect to indigenous people's rights and the environment', got a taste of their own medicine and some bad press in Bolivia as a result. The action was a symbolic protest in solidarity with the people of Oruro, Bolivia, who are suffering the effects of RTZ's toxic waste exports to their land.

Mcbastards

Mcdonalds are taking two unemployed people to court for libel over a leaflet they allegedly wrote about the Mcmurderers. Mcsadbastards infiltrated London Greenpeace to get evidence.

LEGAL NEWS: Helen & Dave lost their appeal against the outrageous denial of a jury trial. They are applying to the House of Lords over this. They WON their Appeal to restore defence evidence which had been ruled out (on rainforest destruction & trade union disputes). However, continuing the huge COVER UP, McD's are still withholding masses of evidence from the defence.

THE TRIAL. Due to continuous pre-trial legal battles the defendants have had no time to prepare for the trial (estimated to last 3 months) which they will be conducting themselves. The first day of the trial, Monday 18th April, was devoted to further legal argument over the COVER UP and the defendants demands for an adjournment. There was a Free Speech/Solidarity picket.

Approximately 60 of the best dressed lockers-on went to parade their gladrags and very nearly shut down this annual sycophantic display of bumlicking to the board. The agenda had only about half an hour scheduled, but the protests extended the meeting for over two hours, it was very generous of the bank to give two rows of seats over to Group 4 Securitas guards, presumably anxious to get news of how their current accounts were being managed. Coincidentally, these same guards just happened be at the forefront of trying to silence the peaceful protests, and one had left a pair of bolt cutters in his trouser pocket. Various attempts to handcuff on to the board's table were scotched amid

much furore, and some who had not been trained with the equipment, were not as familiar with Ann Summers' restraining gear as the majority of the directors. Repeated attempts to get the chairman to disclose the banks' environmental lending criteria were ultimately unsuccessful but a meeting between campaigners and high level Lloyds mandarins has been arranged. Dialogue with the Midland is also taking place. The LAMB'S are coming on in leaps and bounds, although at this rate, they may have to change their name if Midland continue in the present conciliatory fashion. However, they too have an A.G.M coming up which will probably receive a visit from eco-rads seizing the shareholding democracy firmly by the throat!!! LAMB 061-274-4665
