# SHUT WHATLEY OUT A PARTIE OF THE SHOW A PARTIE OF T

At the EF! gathering in Lancashire, it was decided to go for a huge national hit on Amey Roadstone Corporation's (ARC) Whatley Quarry in the Mendip Hills, Somerset. Come and see this massive hole created by the dark forces of industrial capitalism - and get your own back! This will be a totally memorable event, bringing in as many new people as possible, showing them the power of direct action.

Whatley Superquarry is one of EF!'s longest running campaigns. ARC are one of the biggest quarriers in the South West. They are systematically digging up the Mendip Hills in Somerset (and many other places) to supply the roadstone for many of the roads that we are fighting. Stone from Whatley was used to build the road through Twyford Down. Actions against Whatley occurred throughout '92 and '93 as ARC aggressively fought to expand the quarry to double its existing size (it's already one of the largest holes in Europe). This campaign, in conjunction with many other groups - Friends of the Earth, local community groups, Druids etc., succeeded and ARC were refused permission in '94. But, ARC are now re-applying to widen and deepen this giant hole. We've not gone away and we'll win again - tough shit ARC! Local EF! and Freedom Network groups have already restarted actions. This national action is in solidarity with these groups.

We've got 2 months to pull this off. The action will be a joint effort between as many groups as possible. Start mobilising now in your own area, get as many people involved as possible and start organising transport. Please come prepared for an action & bring what you'd expect to find. There will be a full training and information day on Sunday 3rd December from midday, at a campsite near the quarry. This day will give you chance to decide your level of involvement. There will be a camping barn and also we'll make a big fire to keep warm! The action will be on Monday 4th December and we will shut down the superquarry. The camp will be alcohol and dog free. Being pissed in a dangerous quarry is not cool, for you or people relying on you.

Bring tents/marquees, waterproofs, food, musical instruments, vehicles and anything else which you think will make the day run more smoothly! Posters & leaflets are available to start photocopying & distributing (use the poster enclosed to start networking this action).


#### M66, GREATER MANCHESTER

The M66 extension intends to link the M62 at Middleton to the M63 near Stockport creating a motorway ring around Manchester. The route is directly through the narrow band of greenery between east Manchester and its surrounding towns. There are presently 3 sites occupied on the route in Daisy Nook Valley. The contract for the section of road threatening Daisy Nook has been deferred until next spring, so the campaign has even more time to mushroom.

On a recent action, the keys to a digger 'went missing'. Police arrested 3 people for stopping construction work, under anti trade union laws. As soon as they were gone, the keys reappeared and work continued. Protesters attempting to stop the digger were assaulted but, unlike the keys, the police failed to reappear.

Local residents have formed the basis of the campaign, but they need help ... tree-sitters and squat-barricaders are needed now. They also need tarpaulins, ropes, CB

#### TARZAN GETS IT BACK!

Early one Sunday in September and a motley collection of ex-miners, trade unionists and environmentalists are looking for coal with pickaxes and spades. A sleepy Deputy Prime Minister looks out of his window and sees sixty people digging up his lawn! Heseltine, the man responsible for ditching the deep mine industry, will have to fight a planning application for a mine in his back garden. This was just a preliminary visit! Now Heseltine will have to defend his land and state why he objects to the application. Whatever his words, he will be accused of NIMBYism and any arguments about intrusion, pollution, noise, dust or disruption will be widely used by Britain's 40 local anti open cast groups. After 7 hours, much digging, a picnic and a game of cricket, the protesters left. There were no arrests.

#### THE QUERCUS TRIBE

A harvest moon gathering took place at the protest camp on the A30 (Devon) at Fairmile on September 9th. Around 200 revellers turned up and good fun was had by all! However, work continues - people are needed to help construct tunnels which extend under the hillside at Fairmile. At Allercombe camp amazing net systems have been set up in the trees.

#### M65

The barn in the route of the M65 at Guide, Blackburn was demolished on the 14th September. Local farmer, Jack who owned the farm and had been barricaded in it, was met by 100 security guards. He finally agreed to come out and accept the compulsory purchase order. His supporters have pledged to continue fighting the national roads program.

#### ROADS ON THE ROCKS!

The Green Party and Friends of the Earth have launched a campaign to promote a Road Traffic Reduction Bill. It would lead to a national and local strategy to reduce traffic by 10% by 2010. MPs are being lobbied to support the bill and there is a national petition as well as actions to pressurise the DoT. More details - contact The Green Party on 0171 272 4474. Some other groups are working to reduce car numbers by as many as they can find by tomorrow morning! The roads lobby, worried by rumours of £1 billion cuts to the roads budget, are busy pressing MPs to maintain or expand the scale of road building in the next budget. #### GIVE SHELL MORE HELL!

Over the last 30 years, Shell's oil extraction in the Niger Delta area of West Africa has devastated the ancestral lands of the Ogoni Tribe. The Nigerian military dictatorship which controls this region relies on Shell oil for almost half of its foreign exchange income, yet, Shell have washed their hands of all responsibility for the carnage. The Ogoni have suffered at the hands of the Nigerian army, trying to protect their farms and fishing villages. 'Give Shell Hell' are putting out a 'Call to Action'. #### RAINBOW KEEPERS

The Rainbow Keepers - environmentalists in the former Soviet Union - have been holding a protest against the construction of a gas terminal on the eastern shores of the Black Sea. Activists from 15 cities in Russia, the Ukraine and Tadzhikistan have set up their protest camps on the construction site. Peaceful negotiations broke down, resulting in security & police brutality. 4 activists were jailed for 5 days and went on hunger strike in an attempt to be recognised as political prisoners. Journalists were attacked and a vigilante group were encouraged by the oil company to assault the camp whilst the local authorities watched.

#### PRINCE BUTCHERS ANCIENT OAKS

As a result of Prince Phillip's orders, 60 younger trees have been cut down at Windsor Park. Protesters tried to stop the destruction, but workers out manoeuvred them and felled tree's at the far end of the park. Protesters have stopped the workers from tidying up and the remains serve as a constant reminder to visitors of this immense destruction. Ironically Prince Phillip is president of the WWF and has committed a string of indiscretions. Campaign for his resignation! The Crown Estate have 'promised' not to cut down any more trees until they've reconsidered the project. They must now meet the Borough Councillors - who are against the felling - before a final decision is made. There are many trees left to defend including ancient oaks. Get there! Tree sitters are in Queen Anne's drive, off A332 Kings road from Windsor towards Ascot. They're on the left as you leave Windsor and enter The Great Park, Call 0421 518699 or 01635 521770.

#### CAMPAIGN AGAINST THE ARMS TRADE

Protesters from the Campaign against Arms Trade staged an invasion of the Government Arms Fayre, in Aldershot on Sunday September 3rd. The invasion followed a march of over 100 people through the town centre and a ceremony of remembrance with speakers from Indonesia and Kurdistan. The invasion was to draw attention to the effects of the arms trade and to the high levels of secrecy surrounding the arms fayre. 26 protesters were arrested, for aggravated trespass - 2 protesters actually managed to enter the arms fayre! Most people were released without charge.

# **EARTH FIRST! GATHERING**

The 6th UK Earth First! Gathering was held from the 22nd to the 24th of September 1995, at Middle Wood in Lancashire. We camped by a river, miles from the nearest road in what must be one of the most beautiful places ever used for a gathering. About 70 people showed up from around England and Wales. Unfortunately, no one from any Scottish groups could make it.

Earth First! Gatherings aim to occur twice a year, bringing old and new campaigners together to share knowledge on direct action campaigns and to have a good time together.

Below is a summary of some of the workshops and discussions that occurred (The Job Seekers Allowance will be covered in more detail next month). As well as the workshops listed, people spent a lot of time just enjoying a relatively unspoilt area of countryside without worrying about it being trashed at any minute! Thanks to those few people who worked so hard to make it happen. You know who you are.

#### What is Earth First! about?

This was a chance for newly involved people to ask questions. They included:

What is Earth First!? - Earth first! is a network of independent groups. It does not work to an agenda. It's response is emotional - to protect the environment, mainly through direct action.

What can I do and how do I make things happen? - New people should get themselves informed of

What can I do and how do I make things happen? - New people should get themselves informed of local and national campaigns. They can then go along, meet other like minded people and get actively involved. This takes time.

#### TREE CLIMBING AND WALKWAYS TRAINING

Pretty obvious really - walkways are the ropes between trees that allow people to get about!

#### THE GREAT TRANSPORT DEBATE

The Great Transport debate covered issues such as: is working with politicians just a waste of valuable time and effort (e.g. the Brian Mawhinney / Newbury Bypass saga); the road traffic reduction bill; and the massive cuts proposed for the road programme, which could leave some road projects like the M11 unfinished. The debate centred around the effects of out of town shopping centres - the cause of so much travel. The British Roads Federation and their associated supporters such as Weetabix and Marks and Spencers might well find themselves in the firing line for future actions.

#### JOB SEEKERS ALLOWANCE

The Job Seekers Allowance is to replace Unemployment Benefit and Income Support. 'Active signing' means being questioned each time you sign, on your effort to find work. Preliminary campaigns should highlight its affects on wage earners and benefit receivers - raise public awareness. If implemented, then sabotage through over participation. A 'special report' on the JSA, its implications and suggested campaigns will follow in next months AU!

#### LEGAL ADVICE

Solicitor Mike Schwartz was present to advise and answer questions. He covered areas such as - how to sue the police; (details in September AU!, / send a 1st class stamp for back issue.) He also covered what to do when arrested and the effect of the CJA. Issues arising: Legal Aid is only granted when possible compensation makes it 'worthwhile'. A second appeal for legal aid is advisable as a 'fairer' hearing is received. Despite the CJA it's best to stay silent until you see your solicitor. What you say may have further implications until you know what the defence will be. Have your solicitor 'advise you to silence.' Be aware that 'adverse inferences' may be gained from this. The judge may suggest as to how silence should be interpreted. Any doubts - on each case, be well briefed by a good solicitor.

#### RECLAIM THE STREETS

People from Reclaim the Streets discussed organising street party blockades. A legal presence cannot see us managing to protect the earth was extremely useful as was a definite finishing time, with a party to move on to. This would help prevent confrontation when police cleared the streets. Sound systems should be escorted by a have enough people to fight against, they large crowd, preventing confiscation and acting as a focus. Provide food and drink for drivers stuck in the traffic along with leaflets explaining why the road is being blocked. For security reasons people should work in teams concentrating on particular aspects, so no-one knows all the details. A kids play area (eg. a beach in the road) was a positive focus, rather than smashing cars.

#### **OUTREACH**

So, how to get more people involved? There is a lot of public interest in nonviolent direct action campaigns, but few people know how to become involved. Groups need to be more accessible and the Earth First! concept to be more widely presented. Earth First! has an image problem ... losses rather than successes are publicised. Large national actions get more people involved. It was decided to target Whatley Quarry, Somerset on December 3rd/4th.

Basic self defence could be taught before actions, to understand how police use pressure points etc. People stated that more offensive actions were needed as well as defending areas. An Earth First! / direct action road show is being set up to provide information for local events people organise and to introduce people to direct action. It has no money - people with energy needed!

#### THE FOE DEBATE

Charles Secrett, Elaine Gilligan, and Roger Higman from the central Friends of the Earth (FoE) office came along to the Earth First Gathering to discuss links between EFI and FoE. This continued on from two meetings held previously between FoE, Greenpeace, some Earth First groups, Road Alert and Reclaim the Streets.

education, consumer campaigns and research. It is not primarily a direct action organisation. After a wet nights sleep in a leaking marquee, Charles Secrett, (the director of FoE, UK) had the opportunity to present FoE's ideas. He stated that although we may have some different objectives, there are many more important things that we share. FoE wish to help bring the environmental movement together and bring about constitutional reform. To achieve this, FoE suggested a convention - bringing together all sections of the environment movement. FoE requested that EF! help organise the convention.

There was mixed feeling at the gathering as to whether FoE and EF! shared common ground. Although EF! and FoE groups often co-operate on local issues, some activists expressed distrust of FoE after the 'Twyford Down' experience - regarding them as having a different agenda. Some felt FoE were trying to use them as a vehicle to recruit in the 'youth market'. They argued that EF!, having no national organisation, but simply a network, has no business playing politics with FoE. While FoE are basically moderates, EF! is based on a principle of 'no compromise' and encourages radical direct action in defence of the earth. EF! is not about reform. Other EF!ers were keen to develop alliances and cannot see us managing to protect the earth without unity of opposition. Pointing out that we Working together gives EF! a chance to radicalise FoE. Finally, it was agreed that it's up to individuals and local groups to decide how they will work in their locality. They didn't see FoE as 'Corporate Greenies' but argued that FoE local groups had autonomy.

EF! informed Mr Secrett that it works better on a local level. FoE groups are welcome to work locally with EF! groups, and are especially welcome to come along to the Whatley - Shut it Down action on 3rd-4th December.

#### COMMENTS

'So how was it for you?' - Constructive criticisms and comments for future gatherings were obtained anonymously. Compliments on the location - the 'excellent's' and 'inspiring's' were too numerous to be included. Thanks for getting it together, you know who you are!

Considerations for future gatherings: "gender workshops," "not enough time to pick each others brains ... 3 - 4 days next time?" "Football games - a la Swindon!" "Gathering action ... location permitting." "Workshops to be facilitated." "More music and communal space to cater for larger numbers." "Child care definitely needed if children are going to fall in the river!" "More dancing / jigging around." "Access for people with limited mobility." "Mobile phones incase of emergency." "More colour and music ... not just beer and spliff." "Some attitudes were immature and cliquey ... one or two downright obnoxious people - esp during FoE discussion." "Personal responsibility - too many people leaving litter ... sort it out." "The odd trace of unnecessary attitude was unbelievable.". These comments refer to us all. We're not perfect, but we're getting there!

#### COOLTAN ARTS

CoolTan Arts Centre is no more! They left the Old Dolehouse on September 24th, after three years of occupation. 'The Voice' newspaper, who bought the building 18 months ago plan to move in. CoolTan agreed to leave the building - to set up a new DIY centre in Brixton called 'Greenland'. After two and a half months of work into the project, 'Greenland' faced a number of setbacks. The 'Greenland' project is now on hold whilst the search is on for yet more premises...

#### SELLAFIELD PEACE CAMP

Helen and Kate have appeared at Warrington Magistrates, following the Risley Action on Chernobyl Day. Charged with painting the forecourt, they defended themselves using 'preventing a greater crime', - a Chernobyl style accident in the UK. They received a Conditional Discharge. #### SELAR FARM NATURE RESERVE

The battle against the proposed Celtic Energy Opencast Site at Cwmgwrach, South Wales looks like dragging on over the winter. An eviction threat still exists under 'sole possession order' granted to Celtic Energy in May. This is in direct defiance of the Criminal Law Act of 1977. Tree sitters are still desperately needed. The biggest threat at the moment is winter itself as Selar farm is half way up a mountain, but there are plans for alternative energy creation under way. Bring heavy duty sleeping gear and any tarps/plastic sheets. Selar Farm Nature Reserve, Cwmgwrach, Neath Valley, West Glamorgan. Camp tel: 0589 114899.

#### C.J.A.? No Way!

Nearly a year after becoming law the Criminal Justice Act is suffering problems. Specific clauses have recently been legally defeated in test cases. The eviction of a group of travellers in Sussex was overturned after the court decided that the local authority had to consider the human and welfare needs of travellers before eviction.

A man calling himself King Arthur, defeated a charge of trespassory assembly at Stonehenge. This went against his right under European law to freedom of worship.

Only 10% of arrests under the act have resulted in convictions and many police forces have chosen not to use their new powers. Worryingly the act has given the police, as opposed to magistrate, the right to set bail conditions which has resulted in people being arrested on minor charges and given excessive bail conditions including not returning to a protest site.

This first eviction of squatters was attempted in Bristol by the Church Houses Association. The 24 hour notice was overruled by the court, who extended it to 7 days.

#### BLOODY BARRAGE GETS BOLLOXED

Guess What! The Secretary of State for Wales has turned down proposals for a barrage similar to the one in Cardiff Bay. The £70m barrage across the River Usk at Newport was rejected last month by William Hague, on the grounds that it would damage the river and that the barrage's economic potency was flawed. The decision was welcomed, but environmental groups wondered why the Cardiff Bay Barrage is still being built. A reason could be that the Usk is one of Europe's 'top' angling rivers. Fish stocks would be depleted with the barrage in place and surprise, surprise, this is where a few Conservative marginal seats lie.

In a shock development last month, Cardiff Bay Barrage made some drastic cuts in the budget of the Barrage increasing the risk of flooding in Cardiff. We hate to say it, but we told you so...

This year the London Greenpeace fayre is changing its emphasis and will be the Anti - Corporations Fayre. Transnational Corporations dominate the worlds economy and are responsible for the exploitation of people, animals and the environment.
