AND THEY THINK IT'S ALL OVER...!

This month saw the evictions of all the remaining camps along the route of the proposed Newbury Bypass, and what follows is one persons account of that month.

March in Newbury was an intense month. In an attempt to carry out environmental destruction within the European Environmental Law on bird nesting season, the DoT have made the 'conscientious' gesture of trying to destroy bird nesting sites before they build their homes in them. They announced that work would stop on April 5th, and employed a determined eviction team to blunder through the series of 29ish camps along the 9 mile route (no one ever seemed sure just how many camps there were). Bailiffs, tree surgeons, chainsaw men, 'climbers' and mechanical dinosaurs with hords of wage slaves, snooping detectives and blind upholders of 'justice' were all employed by the State to evict a determined and innovative force of tree defenders.

The pro-active actions of the early days, where the destroyers were penned in their compounds and hindered in their early morning convoys, gave way to a more defensive mentality as the daily uncertainty of where the eviction posse was going to strike caused rising levels of insanity. They adopted tactics of chaos, dotting around the route, evicting whole camps, half camps, having night time cordons, sending the police on in advance, making ambushes

and varying their times of arrival. Every eviction was different.

We developed various tactics and innovative defenses where, as well as the basic walkways and treehouse networks, there were tripods, platforms, tunnels, scaffolding poles extending from the tops of trees and various lock on techniques; and each of these worked with various degrees of effectiveness. Ground lock-ons at the base of trees and barrel lock-ons in the branches were particularly successful, with one tree lock-on lasting for six hours.

Last week a protestor was locked onto a platform attached to surrounding trees with one length of steel cable. Bailiffs scratched their heads a lot and eventually erected a scaffolding tower to get the person down. New ideas are often the best.

Richard Turner's 'climbers' are now all stinking rich, hated by more people than ever and banned from various climbing centres. Meanwhile some of the climbing community have been politicised with many of them having come down to the evictions in Newbury and confronted their soul-selling counterparts in the treetops. In Snelsmore particularly, the battles between climbers on both sides were intense and at least one of Richard Turners employees resigned that day. In general though, most of them seem to be hardening to their job and they are using increasingly unsafe practices and violence.

Despite the decline in media interest, wide support continued, with food, money, materials and visiting activists arriving from all over of the country.

Newbury businessmen declared that a high proportion of them opposed the bypass, and an interfaith gathering at Middle Oak brought people together from all beliefs to pay their respects to nature under attack.

Badgers resisted eviction in their Snelsmore setts and Vertigo Moulinsiana, a very small and rare snail managed to get Rickety Bridge a ten day stay of execution in the High Court. Thousands of baked beans also made their own protest against the bypass with many of them flinging themselves voluntarily out of the treetops and onto the heads of invading climbers.

There have been over 700 arrests during

the the last 3 months, and excessive bail conditions have been used against us in an attempt to try and keep people away from the route.

By the last week in March large numbers of people were gathering at Rickety Bridge and what had been one of the last camps to be established became the site for the last big eviction lasting 3 days, with well over 150 people in the trees. This eviction was a little different, as it was no surprise when they arrived, and we welcomed them with the seven dwarves singing "hi ho, hi ho it's off to work we go" blaring over the sound system!

Camelot and King Arthur were evicted on April fools day, followed by the trees at Castlewood and Tot Hill. Mary Hare was saved (actually it turned out that it was off route) and the beautiful Middle Oak has been 'spared' and is now destined to live in the middle of a monster road junction.

All the camps are now evicted, trees lie fallen and funeral fires burn. But off route camps have been set up, sculptures are appearing in the wreckage and people are recuperating their energies. Ding Ding round 2.

So the route is cleared, but strangely none of the contractors are very keen to win the next phase of the contract. Are the DoT being realistic about actually building the road as we hear that they're not doing so well with the M11?

On April 3rd Blandy went to Middle Oak to announce that all the cleared areas were now the property of the DoT, but millions of news viewers across the nation were to see his humiliating retreat from a group of protesters, with his police escort having to fun alongside his Landrover to keep up!

TARMAC AND MOD

Thirty Ministry of Defence police officers joined the direct action against road building last month by occupying offices of Tarmac & Matthew Hall (Amec subsidiary) and seizing documents. Tarmac and Matthew Hall have been accused of "financial irregularities" over the construction of the Coulport nuclear armaments depot (yet another environmentally damaging project) where costs have risen from 58 million to 108 million (of tax payers money).

This is all part of the Trident nuclear submarine development which the MOD overspent on construction costs by 800 million last year & were accused of "mismanagement on a grand scale" by the public accounts committee. The MOD are so concerned that they have set up a phone line for anyone to reveal "irregularities" on multi million pound defence construction! Any dirt anyone? It seems that no-one trusts Tarmac and Amec.

SCRAPPIT

Siston Common & Railway Path Public Info Team are campaigning against the Avon Ring Road Stage II, a route that puts Bristol and Bath's favourite cycle way and footpath under threat. It would wipe out a 1km section of the path, slice Siston Common in half, sever the route of the old railway and destroy an ancient dramway and railway and wildlife habitats. Work should have started in March but SCRAPPIT has filed a legal challenge. The campaign meets every Sunday at 7.30pm at the Kebele vegan centre on Robertson Road, Easton. BIG GREEN GATHERING

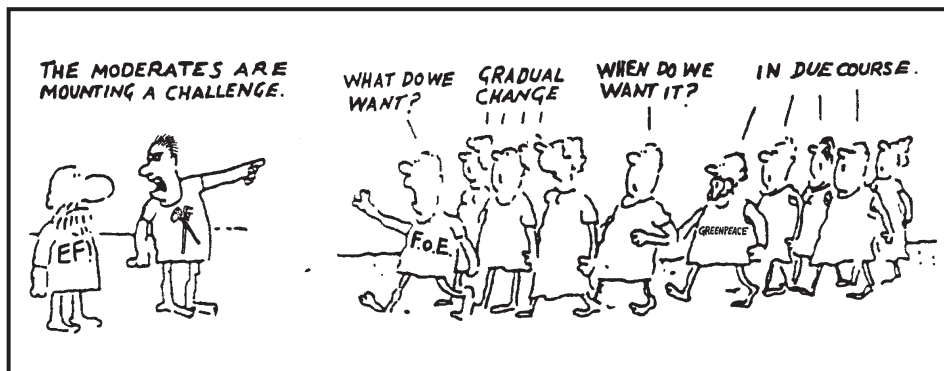

He was taken to Ilford police station then moved to Kings George Hospital, in Ilford where he was pronounced dead on arrival.

The McLibel Trial, now scheduled to last until the end of this year, is currently listening to evidence on McDonald's connections to rainforests destruction. Ray Cesca (McDonalds Director of Global Purchasing) said in court that "McDonald's opened the first of it's restaurants in Costa Rica in December 1970" and that the meat supplied to them since that time "comes from ranches in areas which were deforested in the 1950's and early 1960's". Howard Lyman, a fourth generation cattle rancher from Montana (USA), now an environmentalist, recently testified for the defence on the effects of cattle ranching on the environment and the animals.

NEW WOMEN PRISONS

At Eastwood Park Prison, near Bristol, the new cells, at 6 ft x 6 ft, are 30% smaller than the prison service's own 1994 guidelines. Cells as

small as this were condemned as degrading and inhumane by a Royal Commission in 1878. 56% of women prisoners have mental health problems (Home Office study '91). Such inhumane conditions are bound to increase the already high rate of suicide attempts & self harm among women prisoners. TREES FOR LIFE

Due to trees cut for fuel and timber and to convert the land for agricultural use, less than 1% of the huge boreal Caledonian Forest that used to cover much of the Scottish Highlands remains. Trees for life are aiming to restore 1500 square kilometers of the forest to its natural state, including re-introduction of native wildlife such as Wolves. RUSSIA

On March 5th, the Rainbow' keepers held a peaceful demonstration against a high speed railway. Six of them were arrested. All the action involved was standing by the side of the road. Luckily in this case, it was well covered by media, and police released the activists after 4 hours.

BELGIUM

In Brussels, there was a demo on March 9th in solidarity with the Aspe Valley in the Pyrenees, one of the few remaining habitats of the European Brown Bear. The demo had been forbidden, but this did not stop 250 protesters from showing up. There was no trouble with police.

GREEN TERRORISM ?

The recent front page article in the Guardian newspaper (27th March 1996) reports an alleged attempt by various chiefs of police to request that the anti-terrorist branch starts monitoring green activists. While this may come as a surprise to some (both 'why monitor us we're not terrorists' and 'are we not being monitored already?') it is only the latest in a long line of articles that are trying to push green/direct action and animal liberation activities into the category of terrorism. One purpose of these articles is to try and disrupt our increasingly effective and popular movement by trying to split us into factions along lines that the state sets, in the case of this article, and others before it, between activists that have differing views on violence as a tactic of resistance.

While this article, like others before it, has produced widespread criticism (see for example The Guardian letters column, 30th March 1996) this criticism is not something that we, as radical ecologists, should be joining in with. Our response should not be to play into their hands by denouncing the people in our movement that argue that there is a place for violent resistance in some circumstances nor should it be to lie, as some have, and say that everybody in the green movement is committed to non-violence in every scenario. This article, however, is not to debate the validity of various forms of resistance but to suggest what our response should be to the increasing surveillance and repression that our movement is attracting.

We suggest that our response should be twofold. Firstly, as said earlier, we should not be denouncing people in the movement purely because of different opinions on which tactics to use in defence of the natural world, there is room in this movement for all responses to ecological devastation and we must not divide ourselves on small issues when we agree on nearly everything else. To do otherwise is to play directly into the hands of those that seek to destroy the entire movement. While we should obviously not welcome this increased repression and surveillance we must realise that we are attracting it because we are becoming increasingly effective and popular. If we were ever to evolve beyond a relatively small number of people with comparatively little influence into a mass movement it was inevitable that we were going to attract this type of response from those that put profits before life. In reacting to this increased attention we must not deny our potential as a force for real and lasting change but instead to embrace it and draw up the battle lines between ourselves and those that want to destroy us.



Our second response to these developments should be a reappraisal of our personal and group security. If anybody is in any doubt over the lengths that the state will go to destroy radical groups they should look at recent history in the United States and the way that groups such as the Black Panthers, The American Indian Movement, MOVE and Earth First! have been treated over there.

At the very least our response should be to assume routine interception of mail, tapping of our phones and investigation by state agencies or private detective firms into individual activists and groups. The most simple measures can make life harder for them. One measure that people can and often take is covering up their faces on actions and demonstrations when cameras are present (for example there were four Special Branch photographers at the Whatley quarry action in December last year). In some cases this is a sensible thing to do but be aware that it can look intimidating and can alienate many people that may otherwise get involved with us. One measure that everybody should be taking is to be far more careful about what is said over or even near a phone. In addition to this people should be trying to use a secure address as a postal contact point. A few simple measures can make it harder to identify activists and to work out where that next action of yours is going to be.

In becoming more aware of our security we need to be careful that we do not fall into the traps of firstly becoming so paranoid that we become inactive and secondly, but equally importantly, we need to make sure that our increased awareness over security matters does not lead to people falsely accusing others of being state infiltrators, either of these things will lead to mistrust between people and internal disputes in groups, in which case we will have done the work of those that want to destroy us.
