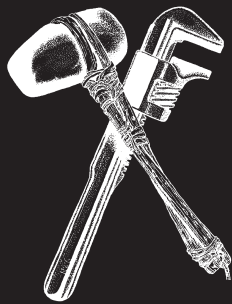

## Dip Dip Delay for Cardigan Bay!

### CARDIGAN BAY CAMPAIGNERS FORCE OIL COMPANY U-TURN

The long running campaign to halt oil and gas exploration of Cardigan Bay, West Wales, notched up another victory this month as the oil giant Chevron, owners of Gulf Oil, announced a second 12 month delay in their drilling program. They were originally due to drill in October 96 but postponed this until October 97 after internal disagreements with their financial partners in the project. Local campaigners have been gearing up since then to fight Chevron's plans for oil rigs in Cardigan Bay. Rallies and public meetings were held, thousands of leaflets were distributed and a boycott campaign against Gulf Oil (which is in deep financial trouble anyway) was launched.

On the 7th of August an alliance of local activists and anti-oil campaigners from around the UK gathered in London at the offices of Chevron (2 Portman St. London W1 0171 487 8100) to mount the largest action of the campaign so far. Eight activists got into the building and barricaded themselves in offices on the top floor. Lots of data was recovered and loads more was "adjusted". Meanwhile more bodies scaled the front of the building to hang banners. Most employees were at lunch when the action happened and couldn't get back in after the 'in'security guards locked up the building. The office sitters were finally removed three hours later. Chevron then announced that they would not be drilling this year and will delay until October 98 at the earliest! They also said they would do an Environmental Impact Assessment (EIA) of the drilling before then, something that even the European Union couldn't get them to do! That night Cardigan Bay was the lead story on all channels of the Welsh TV news, with Earth First! as the winners of a David and Goliath struggle for the Bay.

Cardigan Bay is safe for another year - but

what then? The struggle to save the Bay will continue until its future is secured forever. The discovery of a new group of resident Risso Dolphins and another sighting of a huge Leatherback Turtle during a wildlife survey of the north of the Bay just days before the action proves that Cardigan Bay is a mostly unknown, unspoilt wilderness. We will keep it this way.

### 100 DAYS OF ACTIONS AGAINST FOSSIL FUELS

A coalition of anti-oil campaigners are calling on activists to strike at oil targets over the next 3 months in a concerted 100 days of action. The message is simple: we need an end to the dependency on fossil fuels.

Activists involved with RTS, Delta, Corporate Watch, Platform, 90% Crude, Greenpeace, Oilwatch and Cardigan Bay EF! and others will hold the oil industry accountable for their crimes. The hundred days will begin on August 23rd and end with the Kyoto Climate Summit, where world leaders may begin limiting CO2 emissions but will fail to tackle the real cause of climate change - our mad quest for oil.

Up until now, anti-oil action in the UK has been either in disconnected bursts or focused on the effects of oil: Shell in Nigeria, the Brent Spar, exploration in Cardigan Bay, BP in Columbia, BP in the Atlantic Frontier, Mobil in Peru, Milford Haven, The Braer and Sea Empress Disasters, pollution, workers rights, oil spills, petrochemical toxics. Now with the threat of rapid climate change we must end it before it ends us. The oil industry is large but cumbersome and has never before dealt with an all out assault on its right to exist!

It is intended that on every day of the next 100 some action or event will be happening somewhere. The hundred days include events such as Shell's 100th Birthday, exploratory drilling in Cardigan Bay, first oil coming ashore from the Atlantic Frontier, 2nd anniversary of Ken Saro Wiwa's death, 8th onshore oil licensing round, huge opencast actions and preparatory climate negotiations. Forecourts, delivery lorries, seismic ships, sea going tankers, refineries, oil labs, geology departments, oil fired power stations, opencast, corporate offices, delivery depots, oil conferences, relevant billboards and sponsorship deals are all linked to the oil industry.

### EARTH FIRST! IN VICTORY SHOCKER

Campaigners in North Wales recently set up the Gelli Tree Village to protect deciduous trees around a badger sett in a cash crop forest. The Forestry Commission had planned to clear fell the forest but after a month of the Village's existence they finally noticed the protesters' presence. Campaigners put together a list of demands concerning the area's future management: this was accepted by a nervous Forest Enterprise. Over two hundred coniferous trees and a greater number of deciduous trees all marked for felling were saved. In case this excellent news is not enough, the media attention generated by the campaign helped pressure Forest Enterprise into agreeing to replant the forest with deciduous not coniferous trees and to run the forest under a community management scheme. One commentator has claimed that if this takes place it will be "the first community run temperate rain forest in the Northern hemisphere". Hurray for the riff-raff.

## A MILLION TOILETS OCCUPIED

A camp was set up on a proposed ball clay quarry extension at Teigngrace near Newton Abbot. The quarry, owned by the Watts Blake Beame (WBB) group wants to provide raw materials for toilets, washbasins and tiles. Although the project is on hold because of a potential public enquiry, the camp was served with a possession order and will be in court on the 29th of August. If the project goes ahead, about 1 km of each of the rivers Bovey and Teign will be diverted, affecting an area containing numerous protected species including otters, kingfishers, bats and rare fish species.

## ASHTON COURT QUARRY

## BABRAHAM FARM INSPECTION

On Saturday 14th June animal liberation activists conducted a peaceful and legal inspection of Babraham Farm in Cambridgeshire for breaches of animal welfare laws. Babraham Farm was the first place to conduct bizarre animal experiments in the name of genetic engineering; for example, crossing a sheep with a goat. It was made clear to the police that all activists carried a statement declaring they had no intention of causing damage or theft and were just there to look around.

Within 20 minutes a helicopter and 7 police riot vans appeared. 22 arrests were made, most for the ridiculous charge of 'prevention of breach of the peace'. An hour later this had been changed to 'suspicion of burglary'. All vehicles used on the action were impounded.

After 13 hours activists were released to discover that their houses had been raided in order to search for stolen documents, some having their doors smashed with sledgehammers. No evidence was found.

All 22 were bailed under an 1824 Vagrancy Act. Even the desk sergeant could not keep a straight face when reading out the charges.

This is just one incident in a chain of mass arrests at recent peaceful animal liberation demonstrations - those involved have described this as police intimidation which has no chance of succeeding because activists know that a few hours in a cell is nothing compared to what is happening to tortured animals.

## BASQUE COUNTRY RESISTANCE

The 8 activists who sabotaged the construction of the Itoiz dam in Navarra, Spain last year have been taken to court again. They were originally released due to massive demonstrations and international solidarity. However the new conservative government has decided to restart construction of the dam and to punish the activists. The regional government and constructors were asking for 3 years imprisonment but the Spanish government for 19 years. Dani Untziti is still in prison although he didn't take part in the action, but was involved in the campaign against the dam and is insumiso (refuses military service).

## ENCUENTRO NEWS

From the 25th July to the 3rd August, over 3000 people from all five continents gathered in Spain to discuss how current economic policies are affecting our everyday lives around the world, and how we can create a global network of local organisations that can resist them (no small feat...). Amidst a rainbow representation of people's movements, unfunded groups, unions, individuals, co-operatives and NGOs, the Encuentro opened with a public meeting in the Plaza de Toros on the outskirts of Madrid, where two members of the Zapatista National Liberation Army (EZLN), Dalia and Felipe, spoke of the current militarisation of all parts of Mexico - not only Chiapas - and the struggles of Zapatista

current militarisation of all parts of Mexico - not only Chiapas - and the struggles of Zapatista communities today. Where neoliberalism had meant an end to hope for millions of people all around the world, the message and demands of the Zapatista movement offer renewed hope and energy, and this was more than evident from the way in which Dalia and Felipe were warmly welcomed wherever they travelled.

The week was organised by themes: the neoliberal economy, struggles for culture and education, for land and ecology, and the struggle against patriarchy, and all forms of marginalisation.

In the land and ecology workshops participants heard of struggles in the Philippines against the proposed development of a golf and "Country Club" on 8,650 hectares of land which is currently composed of four villages, rich agricultural land and a beautiful landscape of mountains and sea; of thousands of Indian farmers protesting directly against multinational companies such as Cargill and Kentucky Fried Chicken for their part in the monopolisation of the seed market and of local food-growing areas for meat production; and of the Sem Terra movement in Brazil which has been organising among landless families in 23 states in Brazil, occupying land and campaigning for agrarian reform.

The Encuentro culminated in a meeting of over 2,000 people in the scorching heat, where each group gave feedback on their discussions, and the possibility of creating "an international network of resistance" came closer to realisation. Despite the diversity of all those represented, the struggle is for a common goal and against the same system driven by the laws of profit, and together we are more powerful. As stated in the summons to the Encuentro, "perhaps the most urgent thing to do is to try and break out of this isolation and open spaces to hold in common our struggles, our frustrations and our desires for change".

The energy and encouragement that the Encuentro gave to people as they return to their disparate communities was immense. Not only have concrete plans for international actions emerged (for example against the World Trade Organisation 50th anniversary to be held in Geneva next February, and an international week of action against Maastricht in the first week of December, to name only two), but perhaps most importantly the Encuentro showed that human beings all over the world are seizing the spaces left by the destruction caused by the free market today, and filling them with proposals for self-organisation and viable alternatives.

## GENETICALLY MANIPULATED PRISONER SUPPORT

Unfortunately the governor ignored him as he had two weeks to serve and probably wouldn't die of hunger before being released. ## GENE CROP DESTROYED

An experimental crop of oilseed rape, owned by the US based biotech corporation Monsanto, has been destroyed by local residents at a farm near Coventry.

The action took place on the evening of Wednesday 6th August at Tibs Hall Farm, Kingsbury near Tamworth, Staffs. The genetically altered crop, containing mutant DNA, was uprooted from its experimental plot by people wearing protective clothing. The plants were then broken before being mixed together with 'normal' plants to invalidate the experiment's results.

The mutant DNA in this crop could have easily spread to the surrounding area either through cross pollination or through virus infection. No-one can guarantee that this cannot happen. Several studies have shown that the pollen of transgenic oilseed rape can cross-pollinate with traditional or wild species, spreading the genetic pollution.

## NOTES ON THE AMSTERDAM MARCH FOR SOCIAL JUSTICE

50,000 people marched in Amsterdam against the recent Euro summit and were met with various charges by riot police with batons and tear gas. Bank windows were broken and EU flags pulled down. 200 Italian activists were arrested for allegedly graffitiing a carriage in the train that 4,000 of them had squatted to get to Amsterdam.

Other activities around the Summit included a demo waking up delegates in their hotels - activists got away either by swimming across a canal or pretending to be Italian tourists! Some foreigners were deported when arrested. Spanish olive growers protested against the Summit by giving out olive oil and bread. The final press conference was disrupted as a banner stating 'EUxclusion' was unfurled at the front of the room whilst other activists ranted on the exclusion of environment, non-Europeans, and social issues from the agenda. The action was broadcast live on TV screens around the press centre.

A **database** is being set up of facial images from passport photos which will result in a searchable archive of 35-40 million people. This is allegedly to combat passport fraud but coincidentally several companies are well on their way to developing technology that could match digitised passport images with photos from existing police databases and CCTV cameras

350 people marched to the police station to demand the release of those who had been arrested but were stopped by the police: everyone sat down in protest and was arrested.

Over a hundred went on a hunger strike. 10,000 Kurdish people demonstrated against Turkey joining the EC. ASEED actions took place against genetics; another ASEED action stopped a high speed train and dressed it up as a devil. Other actions targeted Western nuclear expansion into Central & East Europe.

## URGENT ACTION NEEDED FOR OGONI PRISONERS

20 Ogoni men are still in prison in Nigeria awaiting "trial" - framed for murder on the same charges that Ken Saro-Wiwa faced last year. The Nigerian government refuses to grant them bail, much less bring them to trial. The men are kept in severely overcrowded cells with torture, denial of medical care, starvation, and poor sanitary conditions all listed as complaints. This has been described as a deliberate strategy, "Abacha knows that executing them or even trying them will draw unwanted attention. Instead, he seems prepared to let them die in jail untried" *The New York Times*, August 6, 1997.

Testimony by the 20 implicates Shell in their arrest and subsequent torture. "Shell Police replied that nothing can make us free from their hand, and that even if they forgave others, they cannot forgive the indigenes of Bomu and Dere communities because they are the causes of the hindrances to their operations in Ogoniland" - written by two of the Ogoni 20, September 21, 1996. Shell's security force, known locally as the "Shell Police" are accused of numerous incidents of repression of peaceful protest and harassment of activists. ## SMOGBUSTERS AGAINST A1(M)ADNESS

On 5th August members of AGAST (a coalition of groups opposed to the A1 expansion) occupied part of the A1(M) site near Alconbury in Cambridgeshire. Armed with banners, pollution masks and a traffic-fume vacuum cleaner, the protest sought to pour light on the damage caused by vehicle emissions to health and the environment.

The £200 million section of the A1(M) is being built by the Road Management Group (RMG), a consortium of construction companies. The new road is to be a DBFO initiative; a scheme whereby contractors borrow the money to build the road, then recoup their costs from the government by charging an agreed fee for each vehicle using the road over a 30-year period.

## SPITALFIELDS MARKET

A new campaign to resist our old friends Costain has been kicked off. They wish to build the world's largest trading floor for professional gamblers, the London International Financial Futures Exchange (LIFFE) on the site of Spitalfields Market. The plan is to destroy a former fruit and veg market that has become home to hundreds of artists; sports facilities including a swimming pool; businesses providing over 100 local jobs; a craft market; and even an Opera House.

Ironically though next to the City of London Spitalfields is the poorest and most overcrowded ward in Britain, the majority of the local population being immigrants from Bangladesh. The new development is set to destroy this entire community as property speculation pushes up land prices and forces out tenants. A huge local consensus against the development has been ignored by cash-stricken Tower Hamlets Council. Protesters picketed a "regeneration" conference organised by the Civic Trust on the 18th July in Spitalfields Market. ## RTS SUCCESS !

**FINLAND:** On the 9th of August, this time in Tampere, the largest town after Helsinki, 1200 people blocked a major street near the railway station and the party kicked on from 12 to 6 pm after which we had a break before the all-night RTS-continuation party at the beach just a mile from the town centre. The Police had said earlier that week that "because the Helsinki-RTS (17.5.1997) had been 'so peaceful' there would be no police intervention required" [they didn't know why to arrest us]. This time the media was there and we got our message through though the local paper wrote next morning that "the RTS-party had not troubled the traffic" ["Your resistance is futile - submit!"]. Are they trying to challenge us - should we perhaps block the

**BRISTOL:** Over 1000 people turned up in Bristol on the 21st June to block the start of the M32, jamming up the entire Bristol city centre. After the party, that went very well indeed, police moved in to make 22 arrests and call it a riot, however only 4 of these cases are now being followed. Pictures and witnesses of arrests are needed, especially at the illegal raid of the squat the night before. Unfortunately Desert Storm, (veteran sound system), had their rig impounded after the event, it is still unclear if they will get it back. Contact Bristol EF!

**EDINBURGH:** There was a slight clash of the drama culture and ecoculture as a theatre group were involved using the street party as publicity for their play: we want press, yes we'll move Mr. Policeman vs this is a protest - we'll resist the police. However there was a broad range of activists from around Europe, many of whom got nicked and were not being released until a few days later. A large police presence failed to deter the main group from its destination, an empowering feeling. The Scottish police had a totally harsh, non negotiable approach, however activists asked for a consensus decision on moving away, and so a large talking circle was formed where all decisions had to be translated into 12 languages, annoying the police intensely.

## SWAMP STORIES

Following the A30 protest Exeter's local paper *The Express and Echo* recently reported that the Under Sheriff of Devon, Trevor Coleman, is "hiring out a team of 'Swampy Busters' for developers who fear they will be targeted by eco-warriors".

The new Major Protest Unit, set up by Mr Coleman and his colleagues at Michelmores Solicitors in Exeter, will be "targeted at developers tendering for privately funded building schemes - particularly roads passing through environmentally sensitive areas". They are warning potential clients "not to under-estimate the campaigners and their techniques for halting construction".

## RAINBOW KEEPERS ATTACKED

The Rainbow Keepers, who have been blocking the only road into the Rostov Nuclear Plant in Russia since 16th July 1997, were violently attacked by 500 workers, and the camp was burnt down on 29th July. Many of the blockaders were injured as they were dragged out from lock-on barrels, others were viciously assaulted. The next day, the local militia arrested 22 Rainbow Keepers for their part in the blockade.

The blockade carried on with the help of Kosacks (former Russian border army) until the local government agreed to open an enquiry on the beatings (12th of Aug) and open discussions on a potential referendum. ## Cassini - A Star Wars Disaster

On October 6th NASA is planning to exploit its position within the world's major superpower, and place the rest of the planet at a huge risk.

Cassini, a space probe, will be launched into space with 73 pounds of deadly plutonium on board. Just one pound of plutonium, could hypothetically induce lung cancer in every person on earth.

NASA's latest scientific experiment which is being imposed on everyone else on earth has the potential to be a huge disaster, and even NASA's own research indicates that an accident could result in the most toxic chemical known to science, showering down onto earth.

NASA insists the chances of an accident occurring are miniscule, estimating the likelihood that the rocket would explode on launch and release plutonium into the air as 1 in 1500. A fire was reported in the rocket in the beginning of August.

### What are the risks?

The Cassini probe will be launched on the same kind of rocket that exploded over the Pacific in 1993.

Because Cassini's propulsion source doesn't have enough power to send it straight to Saturn, a gravity assist manoeuvre or sling shot manoeuvre will be used. This means sending the unstaffed probe and its lethal load plummeting straight back to within about 400 miles of the earth's surface before using the earth's gravity to deflect it and power it further. This is an operation fraught with technical difficulties.

Since the 1960's the US has launched 24 devices carrying nuclear material into space. 3 have crashed. Not a particularly good success rate.

The radioactive thermonuclear generators (RTG's) used to house the plutonium on board, are only tested using estimated figures and as Alan Kohn, former emergency preparedness operations officer at NASA puts it, it is indestructible like the Titanic was unsinkable.

### Why are NASA subjecting the planet to such dangers?

The plutonium is not necessary. It is not being used as fuel for propulsion but merely to provide electricity for the scientific instruments on board, and experts insist this could be provided by solar energy.

"There is a hidden agenda" say campaigners from Citizens for Peace in Space. "The civilian space mission is being used as a stalking horse for large scale military plans to use plutonium for space platforms and weapons. As the one superpower left on earth now, the US now has its sights on complete supremacy in space".

Between now and 2009, NASA plans to launch many more plutonium missions, including 2 nuclear reactors for mining colonies on Mars in 2007!!

### Profit before planet??

NASA and the nuclear industry view outer space as a new market "untold riches" await mining colonies on other planets. In the US space command document 'Vision for 2020' they state that space forces will emerge to protect military and commercial interests and investments in the space medium. "There will be a critical need to control space to ensure US dominance"

The arms race is moving into space. And the new star wars will be nuclear. Missions like Cassini keep the nuclear laboratories in the US working at full speed and get the public and the media accustomed to the use of nuclear materials in space. It begs the question of whether NIREX will now be looking to use space as a possible nuclear waste dump, as permission is refused for various sites in this country.

*They are committing the lie, the sin of omission, in not telling you the whole truth. They figure if they keep it quiet and just pacify everyone, they can get away with everything they want to do. And they have gotten away with everything they wanted to do up until now. It is time to put a stop to their freedom to threaten the lives of the people here on the Earth. I don't know how they can do this. I don't know what in a democracy they think gives them the right to do a thing like this. They have no such right."* (Alan Kohn, former emergency operations officer at NASA)

## We deal in four types of information :

What's **bad** about a company - to get people motivated to challenge the company, and to help with producing leaflets etc;

How the company is **structured** (eg where its offices are, who makes the decisions, how it's connected with other companies, public relations and lobbying strategies etc) - to help plan campaign strategy;

**Who** is/was fighting the company - to enable coordinated campaigning and to acquire new ideas for actions, as well as sharing information;

How to carry out **more detailed research** into the company.

## How to research companies

Please don't ask Corporate Watch to do all your work for you - what ever happened to **DIY culture**? Corporate Watch has produced a 6-page introduction to corporate research, covering the basics of finding useful contacts, using the internet, working in libraries, media searching, interview techniques and infiltration, plus some general guidelines. Call us for a copy.

We also do workshops at festies, conferences and gatherings.

## The Magazine

One part of the job of getting information out to campaigners is to publish the quarterly magazine. The magazine contains news from the corporate world, features on particular companies, industries and corporate issues, and updates from the campaigns against them. The magazine is available free to EF! groups on the contact list - just ask for it! Otherwise it's £1 (unwaged) or £1.50 (waged). The magazine is available at a discount for bulk orders; if you want to sell it, you can make up to 70p per copy sold, for your group or for yourself.

## Corporate Watcher's Address Book

Corporate Watch would like to see company directors more accountable for the decisions they make. The *Address Book*, which is also free to EF! groups, contains the **home addresses** of the directors of **55 nasty companies**, including the likes of Tarmac,

Costain, Monsanto, Tesco, Sainsbury, British Aerospace, McDonald's, Manchester Airport, ICI, Rank etc. For individuals it costs £2 or £3.50.

## Campaign support

If you're campaigning against a large company, give us a call. If we don't have information on the company, we may be able to suggest someone who does, or we may be able to tell you where to look.

Obviously we can't know everything, nor do we have the time to acquire all the information that might be useful. Rather than developing a centralised core of "experts", we aim to facilitate a **broad network** of campaigners and researchers: **The Corporate Information Network**. We think it's time to stop re-inventing the wheel all the time; we want to **liberate files from filing cabinets**. This can only work if groups feed back to us. If you want us to help you, please enable us to help other groups too. So .... tell us what you're up to, and tell us what you know. Which companies do you have information on? What contacts do you have? What information and other resources do **you** have access to?

## Anyone want a job?

Taking on the entire corporate world is obviously a pretty big job, and Corporate Watch is **VERY** short of people. We need help in most areas, including **IT support, fundraising, information sourcing and management (both on paper and on computer), networking and admin.**

If anyone fancies a change of scene, please come to Oxford - we'll help you find accommodation, and introduce you to the joys of corporate watching. Alternatively, you could come down for a week or two, and we'll show you how to do things, and you can take stuff home with you.

## The BIG BAD DOME

A case for non-violent direct action against the millenium exhibition.

Given £750 million, half of it public money to celebrate the future - what could you do? New Labour in partnership with the ousted Tory party and a handful of multinational companies have the answer: a large plastic dome at Greenwich, London - packed full of shops, shops, advertising corporate glitter, shops and all that is great about the future. Described by Labour's own advisers as "a crock of shit" - it has also been called, "a poisoned chalice" and "a sitting duck." Here a few more reasons why this dome must die.....

**The Place:** Greenwich, London (ie money going to the capital again and sod the rest of the country). The town is already plagued by traffic which will be increased by the 12 million people expected to visit every year. The site is toxic - an old gas works bought from British Gas but will not be cleaned up enough for housing on the site in future. The contaminated material removed from the site will be dumped in landfills in Basildon, Tilbury and Peterborough, (so the rest of the country gets something too - cyanide, arsenic, poisonous tar.) The development involves new road building and helps open up the East End's corridor - a development plan to extend the city onto sensitive Essex marshland.

**The Materials:** the dome will be built of PVC, steel and aluminium PVC, a source of dioxin, one of the deadliest and longest lasting toxic chemicals known. They will still be around when the next millenium comes around and are responsible for hormone disruption and cancer causing effects. It is currently intended to incinerate the dome after a few years which will release more dioxins.

**The Personalities:** designed by Lord Richard Rodgers - also responsible for Heathrow terminal 5, backed by Robert Ayling - chief executive of British Airways and chair of the 'New Millenium Experience Company', overseen by Peter Mandelson - New Labour spin doctor, Michael Heseltine - ex Tory scumbag, Jenny Page and Eric Sorenson - the government's best paid fatcats.

**The Paymasters:** £400 million lottery money - raised from a desperate public. The rest of the money is being solicited from: British Airways, British Airport Authorities, the City of London, Nat West, Barclays, Lloyds, Midlands, BP, GEC, M&S, BT, British Gas to name a few.

**What's in it?** Nobody knows. A spokesman said, "we see it as an opportunity to promote all that's good about UK plc." ( The question is, what's good? )

**Work is happening on-site now.**

The doom dome has to be built on very tight deadlines, imagine if they didn't get it finished on time!

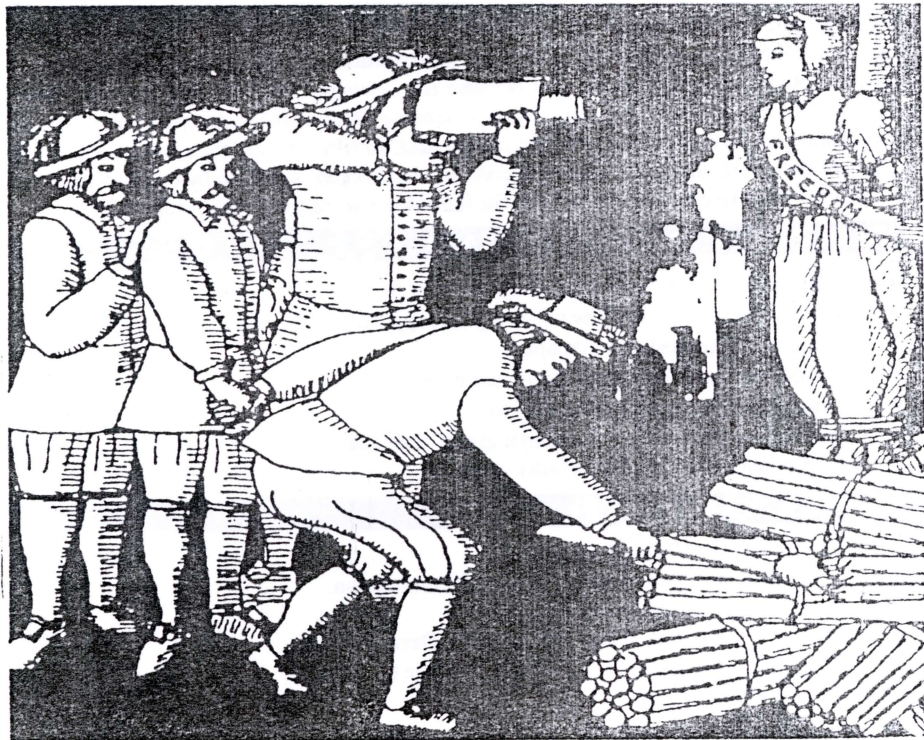

# **STOP THE SHOW TRIAL PORTSMOUTH CROWN COURT TUESDAY, 26TH AUGUST, 9AM**



In Portsmouth, a terrible crime against freedom is about to be committed. This autumn, five alternative journalists could be imprisoned for ten years simply for reporting the news - or even just for knowing others that have or holding opinions that Hampshire's Thought Police disapprove of.

If the State's successful with this Gandalf ('GA-aND-ALF') prosecution, it won't be possible to tell the truth. Listing road protests or animal lib actions will be illegal, let alone comment on them. If Thought Police can bust people for writing -- even thinking -- about direct action, they can bust all those taking it as 'conspirators', even though it's often the only recourse available in a failing democracy.

Freedom of speech, association and conscience are supposedly guaranteed by the UN Declaration of Human Rights and should be fundamental to a free and democratic society. If these rights are denied the Gandalf defendants, they'll be denied YOU too. If the law applies equally to all, the Thought Police will be able to smash down YOUR door at dawn and ransack YOUR home, just as they have to 55

others already under Operation Washington. They'll be able to drag YOU off to prison for what you think, who you know or the way you choose to live your life, just as they are the Gandalf defendants now. This country will be no more democratic than Soviet Russia and apartheid South Africa, where similar laws once operated.

Like secret policemen in all such dictatorships, Hampshire's Thought Police don't want you to know your freedoms are being taken away - some evidence in this case is so secret it's protected by Public Interest Immunity Certificates, gagging orders turning the trial into a farce where not even the defendants and their lawyers are allowed to be present.

All the defendants want is a free, equal, compassionate world but even if you disagree, the Thought Police's 'cure' is clearly more threat to democracy than this 'malady'. They have contempt for the democracy they're supposed to be defending. At committal, the case against one defendant, ALF press officer Robin Webb, was thrown out because the Thought Police violated the very laws they were supposed to enforce. DS Desmond Thomas, leading Operation Washington, admitted then that the prosecution would collapse without Webb in the dock so why's he still pressing on with it? Because the Thought Police are vindictive and out of control - and because successfully concluding this prosecution against the other five defendants will lay the foundation-stone for a police state in UK.
