THE GOOD, THE BAD & THE UGLY

INDIAN DAM VICTORY

A dramatic midnight announcement of capitulation by the state government of Madhya Pradesh has ended the protest occupation of the Maheshwar dam site in India. The site of this enormous hydropower project had been occupied by thousands of demonstrators since January 11th, and an indefinite fast was started on January 26th by area residents worried that their land and homes would be submerged and that environmental impacts on the region would be severe and irreversible. On the evening of January 30th, even as the news that the government had almost accepted the demands spread in the submergence area, thousands of people started pouring in to the occupation site. By midnight, and the time of the announcement, the crowd had swelled from 3,000 to over 8,000. The state government accepted all demands of the protesters, ordering the stoppage of work and a total review of the project, including land acquisition. A decision will be taken on the construction only after the report of a Task Force created to review this project has been obtained. The Task Force consists of representatives of the government of Madhya Pradesh, independent experts and representatives of the Narmada Bachao Andolan (Save the Narmada). With this victory, work on the project has come to a grinding halt.

Protests against the Maheshwar dam project, one of 30 major, 135 medium-sized, and 3000 small dams planned for the whole Narmada Valley, have been going on for more than 10 years. In October, a rally of 10,000 was held in the area calling for work on the dam to stop. Neither the government nor project managers responded, hence this latest act of civil disobedience - the occupation of the valley by a village of tents called 'Sangharsh Gaon' - the Village of Struggle.

Meanwhile, protesters are keeping a close watch on how the foreign players will react to this government review - including equipment suppliers ABB, and Siemens and Bayerische Vereinsbank companies who are giving term loans to the project.

DEAD WOMAN'S BOTTOM TRASHED

The camps at Dead Woman's Bottom were evicted, setting a new precedent. The authorities used section 13 of a 1965 land rights act to evict the protesters. Apparently this legislation (currently being researched) relegates the protestors to the same status as the trees, meaning that they can be evicted with no notice, and that all their homes and tat can be destroyed. The police employed a swift and brutal strategy, catching everyone by surprise, arresting loads of people and immediately bailing them off site. Those remaining on site were given the option of cooperation to rescue their tat or face eviction and have their tat burned.

The police isolated the site with roadblocks to keep away ground support, legal observers and media. Therefore the removal of people from trees by diggers and an assault on an 80 year old man went unrecorded in the media blackout. The whole route was cleared in under 48 hours, despite all the defenses. The site has been levelled and the route secured with compounds.

This eviction procedure needs serious examination as does the allegation that the council sold the compulsory purchase order to ARC for £1. The extent of dangerous, illegal and generally dodgy activities needs to be challenged or else the whole protest camp tactics as we know it could be rendered futile.

LET'S PIE!

Bill Gates, Microsoft magnate, received a cream pie in the face recently from a little known Belgian group whose slogan is "Let's pie! Let's pie! Nincompoop guys!". One of the group, who describes himself as "entarteur" (roughly translates as "encaker" or "pie-er"), had the following to say on the choice of Bill Gates, "in a way he is the master of the world, and then because he's offering his intelligence, his sharpened imagination and his power to the governments and to the world as it is today - that is to say gloomy, unjust and nauseating. He could have been a utopist, but he prefers being the lackey of the establishment. His power is effective and bigger than that of the leaders of the governments, who are only many-colored servants. So Bill Gates was at the top of our lists of victims. The attack against him is symbolic, it's against hierarchical power itself. Our war cry was explicit:

"Let's pie! Let's pie the polluting lolly!"

In a similar incident in the US, on 13th February Procter & Gamble CEO John E. Pepper had a pie thrown in his face at an awards ceremony. The pie-thrower, a supporter of People for the Ethical Treatment of Animals (PETA), yelled, "Procter & Gamble poisons animals! Shame on you, John Pepper! Shame on you!"

"The purpose of the attack was simple", said a PETA spokesman, "This comes after years of writing letters and protesting outside of P&G offices against their animal tests," he said. "Sometimes a polite word doesn't do it. We wish it did. That's why we sometimes do unusual things, such as slinging tofu cream pies."

AIRE VALLEY

Radical action is getting a little less radical now that 'normal' residents are taking up direct action to stop a luxury housing development in their village. A retired policeman, accountants, housewives and managers are all using section 6 squat law to live in caravans and block the bulldozers from starting work on 92 Bryant homes at Aspen Rise, Sandy Lane, Bradford. Locals took advice from residents of the Rye Loaf Camp at the Bingley Bypass protest, after their letters, petitions and public meetings were ignored with disdain by local councillors. Contractors have started to construct a site fence, although this has not stopped mass torchlight trespasses whilst timid security look on. The protest is one of several green and brown belt development hot-spots springing up in the Aire Valley. NUCLEAR TRANSPORT: IT'S A NUMBERS GAME

To date there have been three transports of high level nuclear waste going to Gorleben in northern Germany. Resistance in this area has taken place over the last 20 years with its highlight last March when 30 000 police were needed to "protect" the waste against the will of not only the 15 000 protesters but of the majority of the population. It was the biggest police operation in the history of the federal republic. German law now says that nuclear power plants only get permission to run if they can guarantee that the waste is going to be looked after, which means bringing it either to Sellafield or La Hague or storing it in the shelter in Gorleben or Ahaus. Shipments to Sellafield and La Hague return to Germany after a couple of years and Gorleben is getting too expensive, so the only possibility left is to bring the waste to Ahaus, hoping that there is not going to be such a powerful resistance as in Gorleben.

Police have already announced that they are not going to be able to staff football games in the second half of March as they will have at least 20 000 police in Ahaus. The Castor is leaving from Neckarwestheim and Gundremmingen (Donau) in the week of March 23rd. After that it will go north to Ahaus by train. There is a train track of 4km leading from the main station in Ahaus to the "storing shelter" but police have plans of having a 500m 'demonstration-free' belt either side of the track and of closing the whole town to everybody except for inhabitants. There will be a huge demonstration in Muenster on the 21st of March. After that people will move to the seven camps around Ahaus. NO FUR - OR CLOTHES!

A naked protest in freezing weather was the latest high profile action at Cornyhaugh Mink Farm, Kirkley Mill, Ponteland. Six anti-fur protestors were bombarded by photographers from all over as they arrived clad only in a banner carrying the message 'We'd rather go naked than wear fur'.

The campaign against this particular farm began in July 97 when fur activists carried out an undercover inspection. Footage of mink kept in such appalling conditions that they were driven to viciously attacking one another, was exposed on local TV and newspapers. Since then a small team has sustained an intensive campaign aimed at closing the farm down - demos have included picnics, grim reaper street theatre and tree decoration. 500 PROTESTORS AT HILLGROVE FARM

On 18th January massive numbers turned out for a demo at Hillgrove Farm in Oxon, where approximately 1000 cats are bred for use in vivisection laboratories. Much of the support came from an increasing number of local people committed to seeing Hillgrove close down. Police tactics were heavy-handed as the Thames Valley police swamped the area with roughly one officer for every three demonstrators. Having made their presence felt at the farm they moved off in a procession towards Witney, the local town. About fifty people broke off and went to the home of a Hillgrove worker, to find that members of the police's Tactical Support Group had already hidden inside to run out and attack demonstrators as they arrived, picking out and arresting several.

DOCKERS FINAL SETTLEMENT

After 2 years and 4 months the Liverpool Dockers have ended their fight to get re-instated. Shop stewards spent the month before the final settlement debating the direction of the dispute. Their conclusions were that in certain key areas the campaign had started to falter and that in order not to see good men and women lose everything or risk a collapse from within a collective agreement on the best possible terms had to be accepted. The fact that the Labour government and the TGWU supported the line of the Mersey Docks and Harbour Company was a blow to the striking dockers. They also referred to the, "hard line tactics of the police on the picket lines," as a factor in the decision to bring the struggle to a conclusion. The terms of the settlement were based on up to £28,000 redundancy payment for all ex Mersey Docks men. Approximately 80 dockers are excluded from this, also the limited redundancy payments being made to approximately 2/3 of the sacked dockers will be subject not only to debt repayment but may be reclaimed by the benefits office. "It is with a great sadness in our hearts that we write to all our magnificent supporters and express our deepest gratitude. We have to build upon our internationalism, upon the experiences of all our struggles. Let the words of a great Irish trade unionist capture our thoughts; 'Who is it speaks of defeat? I tell you a cause like ours is greater than defeat can know. It is the power of powers' James Larkin".

FRENCH FARMERS DESTROY GE MAIZE

On January 8th, about 100 farmers from the 2nd largest French farmers union, Confederation Paysanne (CP), attacked a Novartis conditioning and storage plant. After looking around they found 5 tons of transgenic maize which they mixed with non-modified maize before humidifying it - rendering it useless. Shortly afterwards 3 of their representatives were arrested and put on trial on the 3rd of February. Novartis is claiming 1 million US Dollars in damages (they allege that the five tons of seeds destroyed was the sum total of seed kept in cold storage). This sum was probably underestimated so as to turn it into a political trial. Coinciding with its start, a coalition of consumers, farmers and environmental groups launched a campaign to reverse the French governments decision to allow the cultivation of the genetically altered maize. The weekend before the trial, opponents of GE staged protests at two Novartis sites in northern and central France. The court was packed for the trial, with many distinguished witnesses and around a thousand people gathered outside. Sentencing is due around the 18th of this month and it looks as if the three will receive a suspended sentence. France is the first country in the European Union to allow the growing of GE maize. The French government has not yet cleared the production or the marketing of other gene-modified crops like rape seed oil and sugar beet pending further studies and the start of a public debate. WATER MEADOWS OCCUPATION

The occupation of the threatened Bury St Edmunds Water Meadow in Suffolk continues despite gales, floods and cold winter weather. The camp was set up in opposition to plans by the Greene King brewery to build a road through the area. The road has been approved in spite of a local plan which clearly states that there should be no roads or further development on the Meadows.

The campaigners' latest tactic is to take resistance beyond the site and hit Greene King in the pocket with a boycott of their products. There will also be pickets outside local pubs to inform drinkers of the reasoning behind this latest tactic.

At the end of January the brewery responded to opposition to their development plans by demolishing an old derelict bridge which links the camp with its treehouses. Later in the same day two scab climbers went up to a tree house but unexpectedly found it occupied by a protestor bearing a Section 6 Notice. They said nothing and withdrew. Finally, Greene King sent a lorry of rubble to tip in the only entrance to the field and, despite advice from the police, blocked the entrance. GOLF ACTION

Oldham Earth First! took over the garden of councillor John Battye on the 16th of February. They set up a camp, put banners up and played golf with children's clubs. The action took place in response to Oldham council's plans to use Beal Valley partly as a golf course and partly as a dumping ground for industrial waste, including arsenic, cyanide, low level radiation, and the spoil from the M66. Local protesters demanded that the land become a nature reserve as it hosted newts, birds and a wide range of mammals. More actions are planned, as from next month the area is going to see 100 lorries a day carrying waste to the site. Contact 0161 628 5128.

GANDALF UPDATE

Over 50 people took part in the first of a series of monthly Gandalf support group meetings in London on 28th January. The jailing of 3 radical journalists for 3 years each, for reporting news of environmental and animal rights direct actions and protests, has provoked a considerable response...

Thousands are being asked to sign a Solidarity Pledge (see front page) to back the continued reporting of direct actions in defiance of the jailings. # An appeal is being circulated for witnesses to come forward for the defence - contact the defendants solicitor: Des Murphy 01273 602111. # The appeal by Noel Molland, Saxon Wood and Steve Booth against their convictions is likely to be heard in July. # People should have Gandalf literature on stalls and/or organise stalls specifically for Gandalf. # Liberty has produced a general briefing, "Conspiracy, Incitement and the Gandalf Trial", explaining the case and calling for the abolition of the offence of 'conspiracy to incite.' # Concern has been raised amongst journalists and press photographers over the police/state harassment of the press. # The prisoners want to apply to Amnesty for recognition as prisoners of conscience.

The other two Gandalf defendants Paul Rodgers and Robin Webb, are still to be tried. Paul's counsel has argued that his client should be tried separately to Robin - this will be debated further on the 6th March. Robin's trial, with or without Paul, will begin on 27th April.

DUTCH MAI ACTION

On 12th February Dutch activists occupied the entrance of MAI chief negotiator Engering's office, in the Ministry of Economic Affairs in The Hague, The Netherlands. Forty people from the Dutch anti-MAI action group "MAI nietgezien" (= MAI not seen/MAI not for me) went inside the Ministry to protest against the MAI and to demand that the negotiations be extended for at least a year. After an hour the activists met with Mr. Engering and a negotiator for The Netherlands, Marinus Sikkels, and suggested that trying to finish an agreement by the end of April is undemocratic and fraught with problems. Activists also demanded a more open and accessible negotiation procedure, with full information available and public participation. Engering answered that such decisions could only be taken by the governments and would not promise to even attempt to postpone the deadline for the negotiations. MAI POLL DISASTER

MAI negotiations are in trouble again. None of the countries involved really wants to let itself get overrun by foreign investors, (except perhaps the UK,) and so the list of exemptions and exceptions to MAI rules has grown to unmanageable proportions. Negotiations have been rescheduled so that the document will be provisionally signed on the 27th April (back from the 18th). This will be a statement of agreement with the broad aims of the MAI and a commitment to resolve national differences. The date for finalising the agreement has been put back to November.

Corporate Watch is advocating an unofficial national referendum on the MAI. It involves a very simple action that was tried out by the Oxford MAI group on 24th January.

Campaigners set up their own polling stations at two points in the city centre to try and canvas general opinion on the MAI. These polling stations featured banners displaying the messages "Don't let big business trash democracy" and "Vote today

to save your vote"; a table with several briefings by WDM; and a couple of articles from the alternative press about the MAI. There was also a ballot box, voting slips, leaflets and a three-sided screen to create a 'polling booth'. The voting slips offered two choices "I am opposed to the Multilateral Agreement on Investments" and "I am in favour of the Multilateral Agreement on Investments".

One of the polling stations netted a massive 80 votes - 77 opposed to the MAI and 3 in favour, giving the multilateral vote a disappointing 3.75% of the electorate. This hard core of "free traders" collapsed at the second site where only 3 of 175 votes (1.7%) were found to support the MAI. Electoral commentators (and polling officers) were shocked by plummeting support for the OECD's plan. With 97.6% of voters against them the democratic mandate for the Multilateral Agreement on Investment looks shakier than ever. Not that Whitehall or the DTI has ever bothered to ask the people in the first place.

VICTORY AFTER 132 DAY TREE SIT!

On 12th February an American EF!er finally came down from a 16-foot wide, 2000 year old redwood tree which she had occupied for a record 132 days! A group had originally set up home in the tree last December in defiance of the Pacific Lumber Company's plans to cut the ancient tree, known as Luna, or the Stafford Giant.

The loggers attempted various methods to remove the determined EF!ers - cutting in high winds resulted in a large tree striking the redwood last December, while in January Pacific Lumber surrounded the tree with security, flood lights and ropes, vowing to starve out the occupants. Food deprivation was complemented by sleep deprivation as the timber company blasted fog horns as a deliberate disturbance. Further intimidation came in the form of helicopter assaults in which the tree sitters, perched 160 foot high, were shaken by massive updrafts created by the large twin blades of the logging helicopter flying within 30 feet of the platform.

The Pacific Lumber Co. has finally given up its bullying tactics and responded to the concern of the tree's residents and of residents in the local community who have stood firm. In the face of courageous resistance Pacific Lumber pulled out.

SAVED BY SPIKING?

After over two years of protest, it looks like Pressmennan woods has had a reprieve. Landowner John Kinnaird has in the past stated his wish to 'manage' the woodland by thinning it - for BMW dashboards... Recently the woodland management consultants working for Mr Kinnaird said, "The oaks have been put on the backburner. We don't want to have to fight a running battle with protestors to manage the wood. Nothing is going to happen in the near future." This change of heart is directly attributable to the direct and legal action that has taken place. There are reports in the Scottish press that tree spiking has had a hand in the decision. The camps were a great idea, one for the woodland awareness, the other reclaiming common land, both ended in disaster after increasing torment; consequently, neither of the site were available for use when we really needed them. It was difficult to deal with dodgy characters who distracted and diverted the campaign. Post-camp, and after much deliberation it was decided by some that perhaps the least damaging and most certain method of defence was by devaluing the timber. Ceramics are undetectable and break expensive sawmill blades.

A number of trees were carefully spiked, clear warnings were also marked throughout the wood. For further info contact 01368 850630.

EF! CORPORATE TEA PARTY.

South Downs EF!ers targeted one of the worlds biggest multinationals and visited Mark Moody-Stuart, a managing director of Shell, at his home in Sussex. The activists occupied the roof decorating it with banners reading "Murderers" and "Earth First!". Surprisingly they were hosted by the director's wife who served everyone tea - how pleasant.

The action was highlighting the Davos meeting in Switzerland of a 1000 corporations who were cementing their plans to maximise their global power and profit, particularly through the new MAI (Multilateral Agreement on Investment) initiative.

Simultaneous actions took place around the globe in Colombia, Germany, Haiti, Ireland, Italy, Mexico, South Korea, Spain and the USA. Nearly 200 organisations from 54 countries, with a combined membership of 20 million, have released the Declaration against the Globalisers of Misery, which rejects the destructive nature of globalised corporate power and practises.

SPY NETWORK

A global electronic spy network that can eavesdrop on every telephone, email and telex communication around the world has been officially acknowledged in a recent European Commission report, 'Assessing the Technologies of Political Control'. The report contains details of a network of American-controlled spy stations on British soil, including Menwith Hill, that "routinely and indiscriminately" monitors countless phone, fax and email messages. It confirms that the citizens of Britain and other European states are subject to an intensity of surveillance far in excess of that imagined by most parliaments.

For more than a decade former agents of US, British, Canadian and New Zealand national security agencies have claimed that the monitoring of electronic communications has become endemic throughout the world. Rumours have circulated that new technologies have been developed which have the capability to search most of the world's telex, fax and email networks for "keywords". You have been warned.

In the first six months of 1998 the national, regional and international processes will see a wave of conferences, meetings, summits and back room hand shakes, aiming at consolidating the economic and political power of a handful of transnational corporations.

Hot Spring is an initiative aimed at uniting people's action against corporate rule and laying down a challenge to corporate led governments and transnational corporations.

The forces of globalisation and 'free' trade are growing and determining our lives more and more. They are in our food, in our homes, in our education, in our government. It is the result of actions of a number of entities that all work in one direction: the creation of a completely liberalised world market, into which every corner of the world is integrated. These entities are a distinct group of 'world leaders' of industrialised northern countries, an army of uncontrollable bureaucrats in institutions such as the European Union, the World Bank, IMF and WTO; top managers of transnational corporations, all aided by PR firms, 'scientific' think tanks and obedient media to spread their news.

Below is an overview some up-coming meetings, contacts are coordination points for actions:

1. EUROPEAN UNION

(GREAT BRITAIN PRESIDENCY)

Great Britain will hold the presidency of the EU. Informal and formal meetings of ministers and heads of state are planned throughout the year. It will mainly be a push for the Single Market, the European Monetary Union and the expansion of the Union towards the East.

The MAI, should it be signed in its current form, will MAI will put an end to the last remaining obstacles for large multinationals to invest in any country, in order to maximise their profit, on the basis of bad labour conditions, lack of environmental regulation, destruction of local economies and lack of democracy.

The Spring meeting will, among other things, seek further funds for the IMF to deal with crises such as now happening in Southeast Asia.

WHAT IS EARTH FIRST!?

Earth First! is not a cohesive group or a campaign but a convenient banner for people who share similar philosophies to work under.
