## HOUSEBUILDERS' HQ FIELD DAY

On 2nd February a group of EF!ers and friends occupied the offices of the House Builders Federation (HBF), which lobbies for building commuter houses on greenbelt land rather than the provision of social housing.

Armed only with their wits and sets of Oligopoly (a Monopoly type board game based on the exploits of the HBF) the group attempted to obtain previously undisclosed info such as a list of HBF members; an explanation for why 3 of the directors have given the HBF office address as their home address (in breach of the Companies Act 1985); and details of the amount of acreage of greenbelt in 'land banks' held by HBF members.

Various filing cabinets were investigated and a meeting in the company's board room was interrupted: a rather keen secretary tried to keep protestors out but succeeded in locking three of them in the room with the Chief Executive. While this was going on inside, musicians outside performed alternative versions of their favourite chart-topping tunes, including the Verve's 'The Plans Won't Work' - 'All this talk of building homes / It's bringing me down my love / Like a flat for a prat, in a new town, upon

an English down.'

Although no arrests were made everyone was searched on their way out of the building. The action got significant media coverage, especially in the construction trade press.

Meanwhile, in a field near Bradford, activists from Leeds EF! brought work on the greenfield housing development at Sandy Lane in Bradford to a six hour halt by climbing onto the only working digger. Security guards were notable by their absence,

relations with workers were good and there were no arrests. One resident commented "Most people round here are in total support of this kind of action, it's our only option left".

Residents have been taking direct action against the construction of the 92 Bryant Homes since work started including squatting the access to the site, locking the access gates and diverting a stream back across the work site. ## BREWERY FIELDS ARRUGA!

URGENT....strap on your harness, rub your face in the mud and head for North Wales - people are needed at Brewery Fields, near Bangor. Contractors have moved in to build a road and 300 houses and police are imposing 1/2 mile bail conditions.

Brewery Fields is a 30 acre greenfield site, containing woodland, meadow, marsh and heathland and has not been ploughed for over 40 years. The site is owned by Gwynedd Council but has been used as recreation space by locals for decades. They have been campaigning against the development for six years: the only reason that the Council is proceeding is that the land was designated for development in the 1950s.

Last year an application to turn the land into a Town Green was rejected, despite the fact that it was shown to have been used daily by residents as a green for over thirty years. ## X MARKS THE SPOT

To highlight the risk of genetic pollution protestors visited an AgrEvo oilseed rape test site in Scotland this month. The group, a bunch of gnomes called The Human GeneGnome Project, painted a large red X across the field before signing the nearby road with placards declaring the area a 'biohazard'.

"It's time you humans woke up to the dangers of this technology," said a spokesgnome. "AgrEvo have been reluctant to divulge the location of this dangerous experiment. If they won't let the human people know, then we will do it for them. The inhabitants of Fife, human and gnome alike, have a right to know that this crop will pollute the environment while the long-term results are unknown."

Gnome Chomsky added, "The only people who can possibly benefit from GM crops are the multinational biotech companies like AgrEvo and Monsanto - they wish to commodify

and control the means of production of food simply in the interests of profit."

## IT'S MAIZE JIM, BUT NOT AS WE KNOW IT!

The three French farmers who destroyed 5 tons of Novartis genetically engineered Bt maize seed (see French Farmers Destroy GE Maize in Jan AU) have been sentenced: two of them to eight months suspended imprisonment, one to five months, and all to pay Novartis FF 500,000 damages. It is not yet clear whether they will appeal the decision or agree to pay Novartis.

One of the 3 included this in his account to the court:

"Today, I am....accused of committing a serious crime according to the law. The alleged crime is: the destruction of sacks of genetically modified maize. Yes, this is serious, and that's why I assume full responsibility for it....I believe in the ability of everyone to act as an individual. There is no place in our trade union for a hierarchy of responsibility....The strength of our union movement rests on this determination to mobilise free individuals who accept all the consequences of their acts knowing fully the motive for them. Yes, on the 8th of January I participated in the destruction of genetically modified maize, which was

stored in Novartis's grain silos in Nerac. (And the only regret I have now, is that I wasn't able to destroy more of it.). I knew that by acting in this way I was doing something illegal. But it was necessary, and we had no other choice. The way in which genetically modified agricultural products have been imposed on European countries didn't leave us with any alternative. When was there a public debate on genetically modified organisms? When were farmers and consumers asked what they think about this? Never. The decisions have been taken at the level of the World Trade Organisation, and state machinery complies with the law of market forces....A democratic debate simply doesn't exist....Everything has to be allowed to continue in silence. By appearing before you today, I'm aware of being in breach of the law which wants every citizen to be content with expressing her or his views by simply putting their vote in the urn every six years....Yes, this action was illegal, but I lay claim to it because it was legitimate. I don't demand clemency, but justice. Either we have acted in everyone's interest and you will acquit us, or we have shaken the establishment and in that case you will punish us. There is no other issue."

## DERBY DEFIANCE

Derby residents set up a city centre camp in February after plans to develop one of their few green spaces were revealed. The area, Bass Recreation Park and Mill Fleam, was donated to the people of Derby in 1876 with more land being given by the Bass brewery in the 70s. It is now used as a public open space and a grade 1 wildlife site. Despite this, the City Council and developers Norwest Holst intend to bulldoze through the area for a filter road and roundabout. Plans extend to demolishing the existing bus station to build a shopping centre in its place. A new bus station with space for half as many buses is to be built on an area currently used as a small ornamental water garden.

There are already 20 people on site with tree houses being put up and donations made from day one. A local TV company ran a vox pop which concluded that for every 2 residents in support of the road there were 8(!) against. Apparently the Bass brewery are also not particularly happy about the proposed development: whilst they are trying to create more public parks for the millenium they don't want the ones they've already given trashed. ## CHAIN GANG IN OIL PLANT DEMO

Travelling along the approach road to the Coryton BP oil refinery in Essex, a group of daytrippers were so appalled at the sight that they blocked the road. Minutes later their car was straddling both lanes and 2 citizens were attached to the underside of the vehicle. Banners appeared reading *Oiling the World's Ills* and *Tax Oil Now*, a reference to the lenient treatment of the oil industry by government (the UK's tax regime for oil exploration is beaten only by southern Ireland worldwide for its perks). The tax message was particularly apt as the following day Gordon Brown failed to crack down on this over-subsidised energy source. "It's a clear case of corporate welfare before social welfare," said a spokesperson for the protestors. "In the budget we saw the Government pandering to some of the world's richest companies, whilst attacking single mothers, disabled and unemployed."

Very soon the approach road was backed up for at least three miles, with over 100 tankers unable to enter the refinery. The citizens, calling themselves 'UKOOA', or UK Oil Overthrow Association (accidentally echoing the UK Offshore Operators Association) insisted on meeting with the refinery manager to discuss their demands: the shutting down of Coryton and a bottle of organic champagne.

When the manager arrived, there was a 'full and frank exchange of views' between him and the two tucked beneath the car, although he was not delighted to negotiate with the two pairs of shoes sticking out. Eventually the police stepped in and arrested the five unattached citizens for obstruction of the highway. Essex' finest then returned with the largest pair of boltcroppers they could find, intending to liberate the remaining two. But the copper's croppers proved unequal to the task. At which point the fire brigade were called out.

Coryton's only approach road was inaccessible for over two hours, and BP was in the dock on the day its annual report hit shareholders' doorsteps.

## ASHTON COURT

The camp at Ashton Court Quarry is moving into a new phase of activity as work on the site is likely to start any day.

The camp was set up as a focus for the protest against the expansion of Durnford Quarry into Ashton Court, a public park near Bristol. The park was bought by the city council in 1959 who have leased 20 acres at the top end of the estate to Pioneer Aggregates, an Australian multinational. Pioneer want to expand the Quarry, and have been given planning permission, against the wishes of local people.

This will destroy 20 acres which currently supports a diverse habitat.

Part of the land to be dug up includes a wildflower meadow that Pioneer is proposing replanting on another field, half a mile away, which is inhabited by

badgers. The badgers were evicted but have recently re-occupied their sett and need some support to keep possession.....

## OXFORD RECLAIMED

Around 200 cyclists reclaimed Oxford's streets recently to draw attention to the city's pollution and accident rate. They cycled around the historic streets accompanied by a rave rickshaw playing dance music, and the local constabulary themselves on bicycles and motorbikes.

One arrest was made for hopscotch on the High Street - held to be an obstruction of the highway.

## KINGSTON EVICTION

The application for felling trees at Canbury Gardens, Kingston was signed on 17th March. Protesters are now waiting for the forces of darkness to evict them.

The trees on both sides of the narrow park have rope walkways connecting them plus simple treehouses, banners and so on. According to one visitor the most impressive structure is a rickety tower, designed to topple if any of the trees that it is connected to by ropes and walkways is cut down. It's constructed completely of nailed-together bits of wood, is about forty feet high and painted as a medieval tower. Attached to it on one side are letters from children who have visited the camp.

*Directions from Kingston railway station:* turn right out of the station, walk along the footpath, over a bridge, turn right into an underpass under the railway. Turn left immediately after to head straight for the river. Canbury Gardens is on the right as you reach the Thames.

## G8 ACTIONS COMING UP

This May (15th - 17th) heads of state of the eight most industrialised countries will converge on Birmingham to discuss globalisation. They will be joined by the leaders of the World Bank, the UN, IMF and World Trade Organisation (WTO). Although the meeting has no policy making structure it defines issues that will set global agendas and dominate economic thinking for the coming year. After Birmingham the G8 posse will fly to Geneva to sign the latest offering of neo-liberal 'free' trade from the WTO.

Global Days of Action are planned during the G8 summit - raising key social and ecological issues and challenging the right of the G8 to take decisions that affect the world. To the activists descending upon Birmingham watch this space.

## WEST COUNTRY GETS IT TOGETHER!!

On 21st February around 150 people attended the West Country Activist Gathering. The day started with introductions to campaigns going on in the south west, ranging from anti-quarrying to Zapatista support. Four sets of workshops in the afternoon covered Building the West Country Activist Network; Environmental Ploughshares; The Land Is Ours; and a workshop on general issues arising from local direct action. The aim of the gathering was to bring together campaigners in the west to create a stronger support network.

## WOMEN TAKE POLICE BOAT

On 13th March four women walked undetected inside RNAD Coulport, checking on the presence of nuclear materials, before finding an unattended police launch and requisitioning it for their lawful peace work. Driving past a security guard in the watchtower about the jetty where Trident submarines have their warheads loaded, the women drove the inflatable right up to an open hanger. After 30 minutes inspection they decided to check on Trident submarines at Faslane. After passing at least four other police inflatables and launches they reached Faslane and were spotted as they raced by the naval berths trying to find a way to the submarines.

Although the women were arrested no charges have been brought so far.

## ZAPATISTA PICKET

The Mexican government was blamed for the massacre at Acteal in Chiapas by a recent picket outside its Embassy in London. A large banner reading 'Murderers' was stretched along crash barriers. Naming the ruling party, the crowd chanted, 'PRI-istas, asesinos!'. They demanded 'Fuera tropas de Chiapas! (troops out of Chiapas)'. They demanded

The Ambassador declined the invitation to come outside, but an Embassy official invited a small delegation to meet him inside. Four delegates were led to his office and made brief statements. He undertook to convey their concerns to the Mexican government, but gave no clear answer to their questions. According to the Ambassador the government is searching for a peaceful solution, but he would not explain why they still renege on the San Andres Accords. Contact 0181-679 6930

# DOING TIME

*"Under a government which also imprisons any unjustly, the true place for a just man is also in prison."*

Henry David Thoreau

An increasing state reaction to nonviolent direct action is to attempt to control activists through physical imprisonment. Prison has the potential to be an effective deterrent but does not necessarily have to be so. Some activists see punishment as the most important part of civil disobedience, as it is the fear of personal consequences that often prevents us from stopping violence and creating a more just society. The function of punishment - to make citizens internalise control so that they become their own jailers - can be made to lose its effect, according to Per Hørgren. Whether or not this is the case, while prison is a possible consequence of our actions as Earth First!, through non-payment of fines or other activity, it is important to demystify the institution through information and preparation.

## WHAT TO EXPECT

"Those arrested as a result of nonviolent direct action have the advantage over most prisoners of knowing that they are there having made a degree of conscious choice; this knowledge can provide a degree of strength.

Being in prison can give a rounded view of the oppressive society against which we struggle in nonviolent resistance - this may be apparent not just in the organisational systems of prison but in the inmates themselves - a significant number of people are poor and/or in prison for poverty related crime.

Prison is a lonely place. It aims to weaken solidarity, to try to isolate people from one another and reduce one's concentration to dealing with the demands of authority and of one's survival.

Entering prison is like going into another culture - new behaviour norms, language, symbols, new reality. You can expect some overcrowding, frustrating and irritating levels of noise and distraction and little personal space or privacy. It may be difficult to sleep, there may be radios and TVs, slamming bars and loud arguments. Time will be distorted: days will slip by but each hour may seem like an eternity. Food will be starchy and dull. You will learn to wait, for a phone call, a shower, a meal, the answer to a question, the time of day.

The warders in prison have a great deal of power and they are aware of this. Long exposure to prison, whether as a prisoner or a guard, tends to have a corrosive effect on one's confidence in humanity, and the warders are victims of this as well. They expect the worst out of people and are not often disappointed. Their principal concern is to preserve order, which demands an atmosphere of unquestioning respect (fear) for authority. This is their contribution to the process of 'rehabilitation', supplanting personal responsibility with thoughtless obedience and submission. Try not to indulge them in their exalted self image - expect that they should act with respect and compassion whilst remembering that you and they have different jobs to perform. Let them be responsible for keeping order while you are responsible for keeping your conscience.

Just because your body is detained doesn't mean you've got to turn in your conscience and convictions along with your other belongings. Whether in prison or not, the freedom we enjoy is always the freedom we claim for ourselves. Being under lock and key does not deprive you of your essential freedom as long as you continue to insist on your power to say 'yes' or 'no' within the limits of whatever situation you find yourself. It was your commitment to make decisions for yourself about what you should and shouldn't do that landed you in prison in the first place and it remains a good principle to live by."

"With the threat of prison hanging over my head I try and find out as much as I possibly can about the prison I am likely to be sent to...I worry about what the other prisoners are like, will I fit in, how much stuff I can take with me, will I be on my own or sharing...When I arrive different questions become a problem: where do I go to eat, to shower, where is everything, this place is big.

After you come out of prison, take a holiday, or rest, to give yourself time to adjust to being out again and having space to move about. Give yourself time and tell others how you are feeling."

"Prisons and prison experiences vary enormously...The first time I went to a British prison was one of the most hellish weeks of my life: I was beaten up by the guards, denied a vegan diet, taken before the governor three times (and threatened with everything from the punishment block to the psychiatric wing) and put in a cell with someone in for murder and someone in for manslaughter. In contrast, much of my five months in another prison was a leisurely rest - badminton, jogging, table tennis, evening classes, my own cell, passable vegan food, friendly enough screws."

## LETTERS

*'While there is a soul in prison, I am not free'*

Eugene Debs

Writing letters is possibly the most important thing that you can do from the outside. Prison distances you from the 'real' world and a friendly letter breaks down that feeling. Remember that all letters are censored, so do not write anything that may jeopardise other actions or anyone else's freedom. Try and find other things to write about than just how great you think the person is and how you feel that you can't do as much. In the words of a prisoner, "Don't send me socks or sympathy. Send me a picture of yourself at the fence of a missile silo."

If you cannot think of what to write, send a card, postcard, picture or poem. Don't necessarily expect a reply as some prisons limit the amount of letters which can be sent out and in those which don't, the prisoner still has to buy stamps and envelopes.

## VISITS

Remand prisoners are normally allowed regular visits of one to three people (they all have to visit at the same time). Check in advance with the prisoner or their support rather than just turning up - not only will it be disappointing for the person expecting to visit, but as prison is a disorientating experience it can be distressing to expect one person only to see another.

Convicted prisoners are entitled to less regular visits.

## BOOKS, MONEY, FOOD, CASSETTES, OTHER CONSUMER GOODS

Regulations on these will vary - contact the Visitor's Centre at the particular prison for info.

## GENERAL SUPPORT

Action on the above and other aspects of prison can be arranged by supporters on the outside, often via the prisoner's solicitor. Support after prison is also essential.
